# Texas University President Invites Black Lives Matter to Disrupt Conservative Speaker

Dr. Austin Lane, the president of Texas Southern University, was recorded on video inviting Black Lives Matter protesters back into a room from which they had just been evicted for blocking the speech of Texas State Representative, Briscoe Cain. Dr. Lane claimed that he did this because the meeting was not properly scheduled. He then had Representative Cain escorted out for his “safety”. [Of course, if he had not ordered campus police to let the violent demonstrators back into the room, there would have been no threat to Cain’s safety.] -GEG

It’s no surprise that progressive groups like Black Lives Matter want to shut down free speech on college campuses—but they shouldn’t be getting help from school officials to do it.

In at least one recent case, they did. This week, the president of Texas Southern University [intervened to shut down a Federalist Society event](#) featuring Republican state Rep. Briscoe Cain at the TSU law school. Dozens of Black Lives Matter protesters crashed the event, [shouting](#), “When a racist comes to town, shut it down!” and other slogans meant to smear Cain, a member of the conservative Texas House Freedom Caucus. The protesters were eventually cleared from the room, but no

sooner had they left than TSU President Austin Lane arrived on the scene, invited the protesters back in, and had Cain escorted from campus by police under the pretext that it was for his own safety.

The school's official (and unconvincing) excuse was that the event was unsanctioned because the Federalist Society isn't an registered student organization and "proper scheduling procedures were not followed." Yet James Douglas, the interim dean of the Thurgood Marshall School of Law at TSU, [told The Dallas Morning News](#) that the law school's branch of the Federalist Society, which had invited Cain to speak, went through all the proper procedures. "We have a process here in the law school, and they went through our process," Douglas said. "The speaker had a First Amendment right to be heard by the students that invited him."

What's more, [emails published by The Blaze](#) show that university officials were in touch with the president of the TSU chapter of the Federalist Society, Daniel Caldwell, and that the group is indeed listed as a registered student organization. Cain released a statement saying, "The explanation given by the university is blatantly inconsistent with the administration's approval of the event for months. Black Lives Matter was not protesting the paperwork not being filed properly, they wanted to silence speech they disagreed with, and the University allowed it."

This isn't the first time students affiliated with Black Lives Matter have silenced free speech on college campuses. Last week, a group of protesters [crashed an event at the College of William and Mary in Virginia](#), rushing the stage and preventing the invited speaker from continuing. The irony is that the invited speaker was a representative from the American Civil Liberties Union who intended to speak on the subject, "Students and the First Amendment."

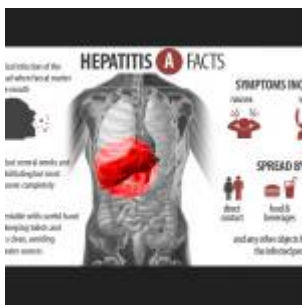
The difference is, at TSU the university president was

colluding with Black Lives Matter to silence free speech and forcibly shut down a duly sanctioned event. Nor is it the first time that TSU has caved to the heckler's veto. Back in May, the school [canceled a commencement speech](#) by U.S. Sen. John Cornyn amid outrage over the Republican senator's support for the Trump administration.

Not that the suppression of free speech by university officials should come as a surprise. The entire anti-free speech movement on college campuses was inculcated and encouraged by left-wing university professors and administrators who hate the idea of the First Amendment and have worked to ensure that dissenting—which is to say, conservative—opinions are excluded or silenced on campus.

## California Declares State of Emergency Over Hepatitis Outbreak that Has Killed 18 People

Eighteen people have died from an epidemic of hepatitis that began in the homeless community in San Diego, and has now

spread to Los Angeles and Santa Cruz counties. Hepatitis A is commonly transmitted by eating contaminated food, California's outbreak is spreading from person to person, predominantly among the homeless community and drug users. The declaration allows state health officials to buy additional doses of the hepatitis A vaccine to try to halt the outbreak.

**California Gov. Jerry Brown declared a state of emergency Friday because an outbreak of deadly hepatitis A has killed at least 18 people in the state, and forced almost 500 to be hospitalized.**

According to the [\*San Diego Union Tribune\*](#):

*The declaration allows state health officials to buy additional doses of the hepatitis A vaccine to try to halt the outbreak, which is already the nation's second largest in more than two decades.*

...

*The outbreak began in San Diego's homeless community late last year, but has since spread outside the region. Los Angeles and Santa Cruz counties are also now experiencing outbreaks.*

*So far, 581 people in California have been sickened with the liver virus, more than half of whom have ended up in the hospital. The virus is particularly dangerous, and can be fatal, for people who already have other liver diseases, such as hepatitis B or C.*

*Federal health officials said last week that, even with the ongoing efforts to slow the spread of the disease, California's outbreak could last years.*

Although Hepatitis A is commonly transmitted by eating contaminated food, California's outbreak is spreading from person to person, predominantly among the homeless community and drug users.

In spite of half a dozen measures aimed at [curtailing](#) the spread of the deadly virus – which is highly contagious and survives for long periods of time – the city and county of San Diego have been [unable](#) to stop its spread.

Basic sanitation is the most effective form of prevention. But installing portable hand-washing stations, sanitizing city streets, and distributing vaccines have barely impacted the outbreak.

The [Associated Press](#) reported Friday that U.S. Rep. Darrell Issa (R-CA) called on the federal government to provide emergency funding to halt the spread of hepatitis A. He reportedly said the outbreak has brought statewide totals to three times the number of reported cases in 2015.

# President Trump Suspends Insurance Company Subsidies

The US House of Representatives sued the Obama administration for payments to insurance companies to cover their losses. The lawsuit argued that these payments were not authorized under Obamacare. The court ruled that the payments were not lawful. [We cannot help asking: So what? There apparently is no intent by anyone to punish those who conspired to commit this multi-billion dollar theft of tax dollars. **President Donald Trump suspended the Obamacare cost-sharing reduction payment program on Thursday, otherwise known as Obamacare subsidies, as part of a strategy to dismantle Obamacare.**

White House Press Secretary Sarah Sanders said in a statement:

*Based on guidance from the Department of Justice, the Department of Health and Human Services has concluded that there is no appropriation for cost-sharing reduction payments to insurance companies under Obamacare. In light of this*

*analysis, the Government cannot lawfully make the cost-sharing reduction payments. The United States House of Representatives sued the previous administration in Federal court for making these payments without such an appropriation, and the court agreed that the payments were not lawful. The bailout of insurance companies through these unlawful payments is yet another example of how the previous administration abused taxpayer dollars and skirted the law to prop up a broken system. Congress needs to repeal and replace the disastrous Obamacare law and provide real relief to the American people.*

The cost-sharing reduction payment program gives health insurance companies subsidies to help cover the cost of low-income and high-cost patients on the Obamacare exchanges. Democrats and Republicans disagree on the impact that the subsidies would have on the individual health insurance market.

The Congressional Budget Office (CBO) [argued](#) in their analysis that rescinding the Obamacare subsidies would cause average premiums on the Obamacare exchanges to increase by roughly 20 percent, while a study commissioned by Senate Republicans and conducted by McKinsey & Co. [found](#) that Obamacare insurance regulations such as community ratings, essential health benefits, and guaranteed issue were largely to blame for the recent spikes in premiums and deductibles. Conservatives such as Sen. [Rand Paul](#) (R-KY) and [Daniel Horowitz](#) have argued that the cost-sharing reduction payment program amounts to a bailout fund for health insurance companies.

The Trump administration's decision to eliminate the Obamacare subsidies arises on the same day President Trump [signed](#) an executive order to open up the health insurance market. The executive order will expand access to association health plans for small businesses, expand the length of short-term health insurance plans, and expand reimbursement accounts for small

businesses.

“This will cost the United States government virtually nothing and will provide people great, great health care,” President Trump [explained](#).

Sen. Rand Paul [praised](#) the action as “the biggest free-market reform of health care in a generation,” adding that the executive order will allow Americans to purchase health insurance across state lines.

The Obamacare subsidies will cost the American taxpayer \$7 billion this year. House Republicans under former Speaker John Boehner [sued](#) the Obama administration, arguing that the subsidies were never authorized under the Affordable Care Act. In 2016, a federal judge ruled against the Obama administration., but the court allowed the administration to continue the payments while the White House appealed the decision.
