

Fascism's Long-Forgotten Roots are in Leftist Ideology



Dinesh D'Souza reports that Giovanni Gentile is the father of fascism and was a student of Karl Marx. Gentile was against "Liberal Democracy" that he felt was too centered on the individual and liberty, and instead promoted "True Democracy" in which individuals were subordinated to the state. Fascists are socialists with a national identity. The bottom line is that there is no significant difference between Fascism and Communism. -GEG

Bestselling author and filmmaker Dinesh D'Souza sat down with PragerU and corrected the record. Dinesh exposes the socialism that underpins Fascist behavior and thought. D'Souza opens by addressing the fact that we know who the ideological founders of Capitalism and Communism are, that being Adam Smith and Karl Marx, but who is the "philosopher of Fascism"?

It must be noted that one of the left's favorite tactic is rewriting history.

It is inherent in any Orwellian tale and it has not escaped our current one. D'Souza argues that most people will not know who this "philosopher of Fascism" is because left-leaning historians have decided to "erase him from history to avoid confronting Fascism's actual beliefs".

Giovanni Gentile is the ideological father of Fascism. He was born in 1875 and was the student of Karl Marx. Gentile's ideas were similarly radical in this age of radical thought and he

contended that the state should resemble a family, an ideal still held by leftists today. During then-Governor Mario Cuomo's 1984 address at the Democrat National Convention, he said America was "an extended family where, through the government, people all take care of each other." In 2012 the slogan for the DNC was "The government is the only thing we all belong to."

How miserably bleak . . .

Gentile, an ardent Socialist, considered his Fascist conceptions to be the most "workable" form of Socialism. "Fascism mobilizes people by appealing to their national identity, as well as their class," D'Souza notes. "Fascists are Socialists with a national identity."

Gentile argued that all private action should "be oriented to serve society". There was to be no distinct boundary separating private interest and public interest. He saw the state as the administrative wing of society, and therefore all of society must do what is in the interest of the state, at the state's will.

Benito Mussolini paraphrased Gentile in his *Dottrina del Fascismo*, "All is in the state and nothing human exists or has value outside the state." Just as bleak as the DNC slogan in 2012.

Pentagon to Undergo First- Ever Audit After Decades of

Sloppy Accounting and Missing Trillions!



After decades of waste, overpayments, trillions of missing dollars and, most recently, losing track of 44,000 soldiers, the Pentagon is about to undergo its first audit in history. It will be conducted by 2,400 auditors from independent public accounting firms. In 2015 alone, a staggering \$6.5 trillion was unaccounted for, with \$2.8 trillion in 'wrongful adjustments' occurring in just one quarter. Corruption goes back to the 1980s when the Pentagon was buying \$37 screws, \$7,622 coffee makers, and \$640 toilet seats. -GEG

After decades of waste, overpayments, trillions of missing or improperly accounted for dollars, and most recently losing track of 44,000 US soldiers, the Pentagon is about to undergo its first audit in history conducted by 2,400 auditors from independent public accounting firms to conduct reviews across the Army, Navy, Air Force and more – followed by annual audits going forward.

The announcement follows a May commitment by Pentagon comptroller David Norquist, who previously served as the CFO at the Department of Homeland Security when the agency performed its audit. "Starting an audit is a matter of driving change inside a bureaucracy that may resist it," Norquist told members of the Armed Services Committee at the time when pressed over whether or not he could get the job done at the DHS.

According to the DoD release:

The audit is massive. It will examine every aspect of the department from personnel to real property to weapons to supplies to bases. Some 2,400 auditors will fan out across the department to conduct it, Pentagon officials said.

“It is important that the Congress and the American people have confidence in DoD’s management of every taxpayer dollar,” Norquist said. -*defense.gov*

The Pentagon is no stranger to criticism over serious waste and purposefully sloppy accounting. A DoD Inspector General’s report from 2016 – which appears to be unavailable on the DoD website (but fortunately WAS archived)- found that in 2015 alone a staggering \$6.5 trillion in funds was unaccounted for out of the Army’s budget, with \$2.8 trillion in “wrongful adjustments” occurring in just one quarter.

In 2015, the Pentagon denied trying to shelve a study detailing \$125 billion in waste created by a bloated employee counts for noncombat related work such as human resources, finance, health care management and property management. The report concluded that \$125 billion could be saved by making those operations more efficient.

On September 10th, 2001, Secretary of Defense Donald Rumsfeld announced that “According to some estimates we cannot track \$2.3 trillion in transactions,” after a Pentagon whistleblower set off a probe. A day later, the September 11th attacks happened and the accounting scandal was quickly forgotten.

And twenty years before that, DoD analyst Franklin C. Spinney exposed what he called “accounting games,” saying “Those numbers are pie in the sky. The books are cooked routinely year after year.” In a 2002 testimony before the House Committee on Government Reform, Spinney laid out the DoD’s accounting quagmire of un-auditable books and budget projections which don’t match reality.

Finally, those of us old enough to remember the 80’s, let’s

not forget the bombshell report on overpayments the Pentagon made for simple items, such as \$37 screws, \$7,622 coffee makers, and \$640 toilet seats which Sen. William Roth Jr (R-DE) was able to whittle down to \$200.

Another Racist Hoax Uncovered in the Military



Marquie Little, a black US Navy sailor on the George H.W. Bush aircraft carrier, claimed to be the target of racial slurs written on his bed, but later it was learned that Little had staged the slurs against himself. Little was not punished for this action but, instead, received counseling. Even though the crew had nothing to do with Little's attack against himself, they, also, have been forced to undergo sensitivity training against racism. -GEG

A black sailor who claimed to be the target of racial slurs written on his bed actually staged the entire incident against himself, the Navy announced Friday.

Marquie Little first posted the pictures of the racial graffiti to Facebook on Nov. 15, stating, "I proudly serve the Navy and this is what I'm receiving in return," but it turns out that Little himself drew the racial slurs, Navy Times reports.

Even though the Navy has exposed the incident as fake, the service nevertheless held training to emphasize that racism is not acceptable.

Navy Cmdr. Dave Hecht, who is a spokesman for Naval Air Force Atlantic, stated Friday that Little's account was shot through with inconsistencies.

"A NCIS-supported command investigation following claims of racially-motivated vandalism aboard the (carrier) has determined that the alleged victim staged the incident himself," Hecht told Navy Times.

"The United States Navy does not tolerate racial discrimination of any form and the well-being of our Sailors is our top priority," Hecht added.

According to Hecht, the sailor, who serves aboard the carrier George H.W. Bush, was not being charged with a crime. Instead, the sailor received "administrative actions" and more training and counseling. He will continue with his regular duties.

Man Receives 15-Year Prison Term for Leaving Bacon at Mosque and Breaking Windows



Titusville, Florida: Michael Wolfe, 37, smashed windows and lights with a machete before leaving bacon by the front door of the Islamic Society of Central Florida Masjid Al-Munin Mosque in January 2016. The vandalism was recorded on CCTV. He plead guilty to vandalizing the mosque itself with 'hate' motives, making it a felony. He was sentenced to 15 years in prison. -GEG

A man who broke into a mosque and left a slice of raw bacon has been sentenced to 15 years in prison.

Michael Wolfe from Titusville in Florida pleaded guilty to the break-in at the Islamic Society of Central Florida Masjid Al-Munin Mosque in January 2016.

CCTV footage shows the 37-year-old smashing windows and lights with a machete before leaving bacon by the front door.

Wolfe pleaded guilty to criminal mischief to a place of worship with a hate crime enhancement on Tuesday, after a plea deal was arranged with the mosque and the police.

A spokesman for the State Attorney's Office, Todd Brown, told Florida Today: "He entered a plea deal and plead guilty to vandalising the mosque itself with hate crime enhancement, making it a felony.

"He waived his right to a pre-sentencing investigation."

In addition to the sentence, Wolfe will remain on probation for a further 15 years after his release.

A charge of armed burglary was dropped in exchange for the guilty plea, Mr Brown said.

According to state records Wolfe has numerous previous convictions for burglary.

Judge Release[s] 19-Year Old Charged in Torture of Disabled White Teen



Chicago: Four black young adults tortured a disabled white teenager, who was beaten, stabbed and degraded for two days, and they uploaded a video of their crime to Facebook. Brittany Covington, 19, pleaded guilty to a hate crime, aggravated battery and intimidation, yet Judge William Hooks, a black Muslim judge, released her without jail time. Three more torturers, Jordan Hill, Tesfaye Cooper and 24-year-old Tanishia Covington await trial. -GEG

A 19 year old Chicago woman who live-streamed the racially charged kidnapping, torture and mutilation of a mentally disabled teen was given 200 hours of community service and four years of probation on Friday.

Brittany Herring Covington – who went by “Herring” on Social Media before her arrest, and “Covington” in recent reports, avoided a possible 33 years in prison on multiple counts, including a hate crime, aggravated battery and aggravated kidnapping – a charge which was dropped along with several others as part of a plea agreement.

Cook County Circuit Judge William Hooks handed down the slap on the wrist to Covington, who pleaded guilty to a hate crime, aggravated battery and intimidation charges – telling the teen

that he could have sent her to prison, but told her “I’m not sure if I did that you’d be coming out any better.”

Hooks warned Covington that should she violate the terms of her probation – which includes a ban from social media for four years, she would face prison time. As part of the plea deal, prosecutors agreed to drop additional charges including kidnapping.

“Do not mess this up,” Judge Hooks said to Covington, who stood in front of him in a blue jumpsuit. Hooks is notably the first African-American president of Chicago’s Federal Bar Association, a past president of the Cook County Bar Association, and a member of the Muslim Bar Association of Chicago.

The brutal attack took place in early January, after four black Chicago teens kidnapped the mentally disabled white teen and held him captive for nearly two days – binding his hands and feet with duct tape and gagging him with a sock, before using a knife to cut and stab the victim while laughing, shouting racial slurs and issuing death threats. In one segment of the livestreamed attack, one of the females can be seen laughing as she punches the victim. At another point, one of the male attackers wraps a cord around the victim’s neck while he groaned in pain, and in another a male approaches the victim with a knife and asks the others “Should I shank his ass?” Other notable quotes include:

“Fuck Donald Trump, Fuck white people”

“There’s gonna be a murder. Pop pop pop”

"We gonna put this bitch in the trunk, put a brick on the gas, like aaaaaaaaah"

"Pistol whip his ass, fool"

After nearly 48 hours, the kidnapped teen escaped after the kidnappers left the apartment to confront a neighbor who had called 911 to complain about the noise coming out of their apartment where the torture was taking place.
