



Soros Funded Pro-Immigration Group Launches App to Help Illegal Aliens Avoid Feds

The Soros-funded group, United We Dream, launched a phone app to help illegal aliens avoid federal authorities. United We Dream says that it is led by immigrant youth and has more than 400,000 members. Its parent organization, National Immigration Law Center, has received hundreds of thousands of dollars in US government grants.

A Soros-funded group called ‘United We Dream’ has launched a smartphone app, *Notifica* (Notify) to help illegal aliens avoid federal authorities.

An open borders group that has benefitted from U.S. taxpayer dollars and is funded by leftwing billionaire George Soros launched a smartphone application to help illegal immigrants avoid federal authorities. The app, Notifica (Notify), is described in a Laredo, Texas [news article](#) as a tool to protect immigrants living in the U.S. illegally by utilizing high tech and online social communications. With the click of a button, illegal aliens can alert family, friends and attorneys of encounters with federal authorities. “Immigration agents knocking at the door?” the news story asks. “Now, there’s an app for that, too.”

The group behind the app is called [United We Dream](#), which describes itself as the country's largest immigrant youth-led community. The nonprofit has more than 400,000 members nationwide and claims to "embrace the common struggle of all people of color and stand up against racism, colonialism, colorism, and xenophobia." Among its key projects is winning protections and rights for illegal immigrants, defending against deportation, obtaining education for illegal immigrants and acquiring "justice and liberation" for undocumented LGBT "immigrants and allies." Illegal aliens encounter lots of discrimination, which creates a lot of fear, according to United We Dream. "We empower people to develop their leadership, their organizing skills, and to develop our own campaigns to fight for justice and dignity for immigrants and all people," United We Dream states on its website, adding that this is achieved through immigrant youth-led campaigns at the local, state, and federal level.

Judicial Watch previously obtained documents revealing the National Immigration Law Center, which started United We Dream received \$206,453 in U.S. government grants.

Both United We Dream and National Immigration Law Center receive massive amounts of money from George Soros' Open Society Foundations.

Only 35% of Public School 8th Graders Proficient in Reading, 33% Proficient in Math

The US Department of Education reported that only 35% of 8th graders in American public schools were proficient in reading and 33% were proficient in mathematics. In some urban districts, the scores were lower, such as Detroit that showed that 7% of 8th graders in Detroit public schools were proficient in reading and 5% were proficient in math.

Sixty-five percent of the eighth graders in American public schools in 2017 were not proficient in reading and 67 percent were not proficient in mathematics, [according to the National Assessment of Educational Progress test results released by the U.S. Department of Education](#).

The results are far worse for students enrolled in some urban districts.

Among the 27 large urban districts for which the Department of Education published 2017 NAEP test scores, the Detroit public schools had the lowest percentage of students who scored proficient or better in math and the lowest percentage who scored proficient or better in reading.

Only 5 percent of Detroit public-school eighth graders were proficient or better in math. Only 7 percent were proficient or better in reading.

In the Cleveland public schools, only 11 percent of eighth graders were proficient or better in math and only 10 percent were proficient or better in reading.

In the Baltimore public schools, only 11 percent were

proficient or better in math and only 13 percent were proficient or better in reading.

US Judge Orders Iran to Pay \$6 Billion to 9/11 Victims. What?

Tehran has been ordered by a US court to pay more than \$6 billion to victims of the 9/11 terrorist attacks, despite the fact that most of the plane hijackers were Saudi nationals, and no direct link was ever found to Iran. On Tuesday, a federal judge in New York found Iran, the country's central bank, and the Islamic Revolutionary Guard Corps liable for the deaths of more than 1,000 people in the September 11 attacks. As a consequence, District Judge George Daniels ordered Iran and its entities to pay over \$6 billion in compensation to the victims' families.

The default judgment seeks compensation of \$12.5 million per spouse, \$8.5 million per parent, \$8.5 million per child, and \$4.25 million per sibling. The US could potentially retrieve the sum from billions of dollars in Iranian assets that were frozen in the US and Europe over the years. This is unlikely, however, as the ruling is seen as symbolic and unenforceable.

It is not the first time that Daniels has issued default judgments against Iran. In 2011 and 2016, the New York judge ordered the Islamic Republic to pay billions of dollars to victims of the attacks, which killed nearly 3,000 people.

Tehran has yet to react to the latest ruling, but has previously dismissed such accusations as ridiculous, given the fact that none of the perpetrators were Iranian citizens, and no investigation ever found direct links to Iran.

"A record low for the reach of petrodollars: CIA & FDD fake news w/ selective AlQaeda docs re: Iran can't whitewash role of US allies in 9/11," Iranian Foreign Minister Mohammad Javad Zarif wrote on Twitter last year.
