



Federal Judge Releases Illegal Alien After Ramming Car into Daycare Center

Marion County, Indiana: A federal judge, appointed by Ronald Reagan, released an illegal alien from Mexico, Juana Loa-Nunez, who was charged with ramming a car into a church daycare center and fleeing the scene. A teacher sustained a broken leg. Nunez has no drivers license. She was released on only \$250 bail and has disappeared. The judge ordered the release, because ICE failed to provide a criminal warrant or a criminal probable cause affidavit for the County to detain undocumented individuals. This is not required for American citizens or legal immigrants. Only illegals benefit from this rule. -GEG

A federal judge released an illegal alien who has now disappeared after being taken into custody for allegedly ramming a car into a daycare center, causing serious injuries to a teacher.

Juana Loa-Nunez was arrested on May 7 after she allegedly crashed her car into an Indiana church daycare center and then fled the scene, WTHR Channel 13 reported.

One teacher, Jessica Parks, was hit during the accident and suffered a broken leg and other injuries.

Loa-Nunez is reportedly an illegal alien who has no driver's

license. She was arrested by the Marion County Sheriff's Department, but by Friday, authorities released the suspect from jail without notifying U.S. immigration officials. The suspect has since disappeared, authorities said.

The sheriff's department was severely criticized by Ricardo Wong, head of the ICE Chicago field office, who called the release "brazen."

"Without any regard for the safety of its citizens, on May 10," Wong wrote in a press release, "Marion County brazenly ignored an immigration detainer and released a Mexican woman from its jail without first notifying ICE."

"Marion County allowed this woman to go free, and she continues to be a danger to anyone else who happens to be on the same road she drives," Wong pointedly added.

But Marion County sheriffs deflected the criticism by saying a federal judge ordered them to release the suspect.

Indonesia: Entire Family of Suicide Bombers Blow Up Three

Christian Churches

Indonesia: ISIS claimed responsibility for members of a family, including pre-teen girls, blowing up three Christian churches, killing at least 10 people. The father was reported to be the leader of a local terrorist cell who blew up a Pentecostal church, two male teenagers blew themselves up at Saint Mary Immaculate Catholic Church and, in the third bombing, the mother and two daughters, ages 9 and 12, detonated suicide vests at another Christian church. -GEG

An entire family of suicide bombers, including pre-teen girls, attacked three churches in Indonesia on Sunday, killing at least 10 people and wounding dozens more, national police said.

The clan of terrorists is believed to have ties to Jamaah Anshar Daulah (JAD), an extremist group that is affiliated with the Islamic State network in Indonesia. The attackers came from a single family whose head was the leader of a terrorist cell in Surabaya, the port city where the bombings occurred, according to National Police chief Gen. Tito Karnavian.

“We have identified the bombers,” he said Sunday at a press conference, according to the Jakarta Post. “It is highly likely that they shared a familial background.”

The attack struck three separate churches in Surabaya, the capital of Indonesia’s East Java province and the island nation’s second largest city. ISIS claimed responsibility for the bombings through its propaganda agency, Amaq, describing them as a “martyrdom” operation against Christian “crusaders” and security personnel.

California Proposes Trading A President's Day for May Day, Traditionally A Day to Celebrate Communism

California Democrat Assemblyman, Miguel Santiago, introduced a bill proposing to allow schools to replace Washington's Birthday or Lincoln's Birthday with "International Workers' Day", better known as "May Day". This has become universally recognized as an annual holiday to celebrate Communism. Although the bill was rejected (this time), 45% of the legislators present voted for it. -GEG

The California Assembly discussed Thursday a bill that would replace Abraham Lincoln or George Washington's birthday with International Socialist Workers' Day as a paid holiday.

California Democrat Assemblyman Miguel Santiago introduced Bill AB-3042, which would allow schools to replace Washington Day and Lincoln Day with Presidents' Day and install an "International Workers' Day" – conventionally known as "May Day" – as a second holiday.

Illinois Proposes Plundering Homeowners to 'Fix' Pension Problem

Illinois has the highest property tax in the nation, with an average of 2.67%, and as high as 5% in some areas, yet the Federal Reserve Bank of Chicago proposed an additional 1% rate hike to cover the state's underfunded pension problem. Any improvements to one's property would increase the tax rate, a policy well designed to cause homes to fall into disrepair. The new tax would push down the price of homes, thus punishing current homeowners. Even so, the revenue would help only five state pensions, while 650 county and city pension funds remain to be 'fixed'. [God help property owners in Illinois.] -GEG

An audible gasp went out in the breakout room I was in at last month's pension event cosponsored by The Civic Federation and the Federal Reserve Bank of Chicago. That was when a speaker from the Chicago Fed proposed levying, across the state and in addition to current property taxes, a special property assessment they estimate would be about 1% of actual property value each year for 30 years.

Evidently, that wasn't reality-shock enough. This week the Chicago Fed published that proposal formally. It's linked

here.

It surely ranks among the most blatantly inhumane and foolish ideas we've seen yet.

Homeowners with houses worth \$250,000 would pay an additional \$2,500 per year in property taxes, those with homes worth \$500,000 would pay an additional \$5,000, and those with homes worth \$1 million would pay an additional \$10,000.

Is the Chicago Fed blind to human consequences? Confiscatory property tax rates have already robbed hundreds of thousands, maybe millions, of Illinois families of their home equity – probably the lion's share of whatever wealth they had.

Property taxes in many Illinois communities already exceed 3%, 4% and even 5% of home values. Across Illinois, the average is a sky-high 2.67 percent, the highest in the nation.

In south Cook County they already average over 5%. Most of those communities are working class, often African-American. The Fed says maybe you could make the tax progressive by exempting lower values, but that's very difficult to do and, if you did somehow exempt the poor and working class, the bill pushed to the others would be astronomical.

Those rates have already plunged many communities into death spirals, demanding an immediate solution, but the Chicago Fed apparently wants to pour on more of the accelerant.
