



# Obama Congratulated South Africa on Being an Inspiration Just as the Gov't Prepares to Seize Land from White Farmers

Tucker Carlson reveals that Obama gave a speech in South Africa last month and thanked SA President Cyril Ramaphosa for “inspiring new hope in this great country!” Ramaphosa announced he will change his country’s constitution to seize land from white farmers, without compensation, which is purely based on racial grounds. Many white farmers have been brutally killed and many more are fleeing the country for their lives, and Tucker says that Obama must know this. The land grab is an emotional reaction to populist rhetoric, without any thought of the adverse consequences that includes loss of foreign investment. In addition, about 70% of the eight million hectares of the land that was previously seized and redistributed in 1994 is now fallow.

The proposed amendment to the South African constitution that will see farmers’ land seized without compensation will scare

away foreign investors and imperil food security, the head of Transvaal Agricultural Union told RT.

South African President Cyril Ramaphosa announced on Tuesday that the ruling African National Congress (ANC) would formally introduce an amendment into the parliament that would legalize the redistribution of land, most of which has been owned by the country's white minority since the 1600s.

Ramaphosa cited the overwhelming support the controversial proposal received at public hearings, arguing that the expropriations would *"unlock economic growth"* and *"bring more land in South Africa to full use."*

Bennie Van Zyl, the general manager of the Agricultural Union of South Africa (TAU SA), believes the result would be the exact opposite.

*"For us, this is a pity that they've made their choice, because no one will invest in this economy and we actually need growth to address the realities of South Africa. So we have great concern for this approach,"* Van Zyl said.

He said that some foreign countries have already reached out to the union and warned they would have to pull the plug on investing in South Africa's agriculture if the expropriation law is enacted.

*"A lot of foreign countries that have already contacted us as an organization say if that is the case, we are not willing to invest in your country anymore,"* he said, adding that the law is going to *"kill"* investment.

*"And if the ANC goes through with this, it will be devastating for this country,"* he said.

Past experience of expropriation isn't reassuring, either, as many of the farms that have been handed over under the ANC have gone out of production.

It is estimated that the major share of the land transferred since the apartheid system's collapse in 1994 suffered a drop in production or is no longer cultivated. The Economist [reported](#) that about 70 percent of the eight million hectares of the redistributed land is now fallow.

## **Paul Manafort, Trump's Former Campaign Manager, Faces 305 Years in Prison for Tax Evasion**

President Trump's former campaign manager, Paul Manafort, became subject to Mueller's investigation as a means of obtaining incriminating evidence against Trump. The first set of slides covered the National Training Center (NTC), introducing aspects of military combat to the

politicians. NTC claims that its land mass is the size of Rhode Island with ample maneuverable space for war games. Jade Helm-15 war games designated this area as hostile territory for training purposes.

The slides taught the politicians how to removing citizens from public meetings and how to handle a contentious crowd. The assumptions are that taxpayer citizens are the enemy.

The next topic was the 'Smart City' program that uses the deployment of sensors and the continuous collection of data. The program will be implemented with 5G technology that connects surveillance devices. 5G is a military-grade weapon with millimeter wave technology which, incidentally, has not been tested for adverse effect on human health. The presentation actually states that one of the reasons they are implementing the Smart City program is "Because we can."

A particularly disturbing part of the presentation is the analysis of the new laws that minimize the punishment of crime and mandate the early release of prisoners. The US Supreme Court ruled that California's prisons were too overpopulated and ordered the State to reduce the prison population. The State implemented AB109/ Prop 47/ Prop 57 which mandates early release for prisoners and downgrades serious crimes – essentially de-criminalizing violent and serious crimes. Theft of items less than \$950 has been reduced to a misdemeanor, even for repeat offenses, which encourages theft. Many violent felonies were re-categorized as 'non-violent', including assault with a deadly weapon against a police officer, assault with a deadly weapon on a civilian, exploding destructive devices with intent to cause injury, human trafficking of a minor, domestic violence, rape and sodomy on an unconscious or drugged person, and committing arson on forest land.



# Majority of Liberals and Democrats Say Illegal Aliens Should Be Given the Right to Vote

A new poll shows that 54% of Democrat voters and 53% of liberal voters want 12-million illegal aliens residing in the US to have the right to vote if they pay taxes. Nearly 60% of all voters said illegal aliens should not be given voting rights. Giving the illegal-alien population the right to vote would almost ensure Democrat dominance in statewide and national elections, because foreign populations are vastly more likely to favor Democrats because of the the welfare programs they advocate. -GEG

# Ignoring an Attack by A Somali Man in Rochester, Minnesota, in Which The Victim's Eyes Were Gouged Out

The mainstream media is ignoring a vicious attack in which Mahad Aziz, 18, is accused of using his bare hands to tear out the eyeballs of a 74-year old man, believed to be his relative. Neighbors, who are immigrants from Somalia, report that Aziz was likely mentally ill. The media has declined to disclose Mahad Aziz's immigration status, or how he arrived in the US, or even whether he has a criminal history. [A gruesome attack of this kind normally would have been amply reported in mainstream media. The fact that the story was buried is, itself, a story just as disturbing as eye-gouging. The only conceivable reason the story would be ignored is that the attack was committed by a young man from the Somalian immigrant community, and mainstream media is committed to manipulating the news in such a way as to avoid creating public opposition to immigration from countries with cultural values that differ widely from traditional American values.] - GEG

Rochester, Minnesota: Mahad Aziz, 18, described as a "teen" instead of an adult by some news sources, is in a mental hospital following his arrest on accusations that he attacked a 74-year old man, believed to be a close relative. The elderly man suffered injuries that included the gouging and removal of both of his eyes during the beating and most of his teeth were knocked out. Aziz used his hands to tear out the victim's eyes. The eyes are missing and, according to police, may have been eaten by Aziz or forced into the victim's body. Police found Aziz straddling the victim, who was lying in a



pool of blood at the scene.

Aziz was taken for a mental evaluation before being transported to jail on a charge of first-degree assault. He reportedly had to be taken back to a local hospital after trying to rip out his own eyes.

William Barnaba, a neighbor and friend of the victim, called attention to the fact that, in Somali culture, parents are not usually attacked. He went on to say, "in Africa, we don't really put it in consideration that mental illness is a problem." Another neighbor, Nasa Abdelrahman, said, "in our culture, if someone has a something like that and he needs help, their families hide it."

No one has reported if Mahad Aziz has a prior criminal record or what his immigration status is or how he arrived in the US.
