



MS-13 Gang Members and Criminals Embedded in Illegal-Alien Family Units Are Pouring over the Texas Border

Texas: The Rio Grande Valley Border Patrol Sector is reporting a record number of illegal family migrations from Central American countries as a result of the reversal of President Trump's promise to curtail illegal immigration and human trafficking. An alarming number of MS-13 gang members and criminals are embedded in large migrant groups and try to disguise themselves as unaccompanied children belonging to family units. The border is still out of control, and Congress refuses to change laws that would allow the US to deport illegal immigrants, like most other countries. In other words, the US government is the major cause of illegal immigration. - GEG

MS-13 members and other criminals are embedding themselves among a record number of "family units" pouring over the Rio Grande Valley sector of the Texas border with Mexico following the uproar and reversal of President Donald Trump's efforts to curtail human trafficking and illegal immigration at the southern border. Trump was attacked by Democrats, the media, open border activists and the courts for holding adults for criminal and deportation processing apart from minors found

with them at the border.

Recent press releases by the Rio Grande Valley Border Patrol Sector indicate how out of control is the border.

Also, a report Wednesday by [local KVEO-TV](#) featured the Border Patrol stating the problem in the Rio Grande Valley is worse than the flood of illegal alien families in 2014 under the Obama administration.

The Rio Grande Valley Border Patrol Sector is reporting a record number of illegal family migrations from Central American countries. The previous record was set back in 2014.

At sector headquarters in Edinburg agents say those are record breaking numbers. However, what is more concerning is the influx of criminals trying to get into the country illegally.

Agent Marcelino Medina says, "What we consider threats in the mix, we continue to see gang members, criminal aliens inside these groups trying to disguise themselves among the family units and unaccompanied children."...

...Recently, in two separate incidents, Border Patrol agents apprehended 150 individuals comprised of family units and unaccompanied children all from Central American countries. Agents say it's these large groups that concern them because of individuals trying to hide their criminal identities.

"We have seen sexual predators, people wanted for murder, and people wanted for assault. We've even encountered several types of gang members; MS-13 and 18th Street gang being the most prevalent." Added Agent Medina...

10,000 People Have Cancer from 9/11 Dust – Which the EPA Said Was Nothing to Worry About

The 17th anniversary of 9/11 is approaching, and a new report shows that 9,795 people, many first responders, are suffering from cancer caused by inhaling the highly toxic dust. The report is from the federally funded World Trade Center Program, which reports 400 deaths from this source. Following the demolition of the Twin Towers and Building 7, the government said the air was safe. One week after the attacks, Christine Todd Whitman, Administrator of the EPA, assured people in New York and Washington, DC, that “their air is safe to breathe, and their water is safe to drink.” -GEG

The city is approaching a terrible milestone – nearly 10,000 people have suffered cancers linked to the toxic dust and smoke at Ground Zero, The Post has learned.

With the 17th anniversary of the Sept. 11, 2001 terror attacks a month away, the federal World Trade Center Health Program has counted 9,795 first responders, downtown workers, residents, students and others with cancer deemed 9/11-related.

In all, more than 1,700 responders and others affected have died, including 420 of those stricken with cancer, officials said.

“9/11 is still killing,” said John Feal, an advocate for WTC responders. “Sadly, this fragile community of heroes and survivors is shrinking by the day.”

Another East German Town Erupts in Protests After German Citizen Dies Following a Brawl with Migrants

Anti-immigration protests continue in Chemnitz, while new protests are developing in Kothen, after a 22-year-old German man died following a brawl with two Afghan nationals. The victim reportedly fell and hit his head during a fight when he intervened in an argument involving three Afghan men and a pregnant woman. Authorities are pushing the narrative that the 22-year-old died from a heart attack due to a pre-existing condition. RT reported that two water cannons were brought

into town, and the mayor advised people to remain at home. [As usual, the media reports the anti-immigrant crowds as 'right-wing' and 'neo-Nazi', but we believe the vast majority of participants do not fit those labels. Yes, there are a few in the forefront whose mission is to provide an apparent justification for the report, but It's just a means of leading readers to think that the only people who oppose rampant immigration are unsavory. Propaganda has never before been so finely honed.] -GEG

Far-right and opposition anti-fascist crowds have taken part in protests in Köthen in eastern Germany, where a German man earlier died following an alleged fight with Afghan men.

Police were deployed to help prevent violent clashes and the city's mayor had advised residents to stay at home.

The 22-year-old fight victim was said to have died of a heart problem not directly linked to his head injuries sustained in the incident.

Two Afghan suspects have been arrested.

Prosecutors said that a post-mortem examination suggested the victim, who reportedly intervened in an argument involving three Afghan men and a pregnant woman, did not die directly as result of the injuries he suffered when he fell and hit his head during the fight.

On Sunday, a crowd marched through the city and lit candles as a tribute the victim.

A local pastor, Martin Olejnicki, said that every effort now had to be made to ease tensions, adding that the church would pray every day "for the victim, his family members and peace in the city".

"It is always a kind of danger – we just had Chemnitz – and so things could escalate and I believe nobody wants that," he said. "That's why we are trying to appease all sides and to talk to people and tell them that it's not the moment to let

things escalate.”

Earlier, neo-Nazi groups took to social media to call for protests in Köthen, which is about 160km (100 miles) north of [Chemnitz, where a similar incident sparked violent protests two weeks ago](#).

“Pull out your pocket Constitution and see who the commander in chief is, who has all the executive branch power in his hands,” said Coulter. “He has the Department of Defense. He

has Homeland Security. I mean, if we were suddenly attacked by China, he wouldn't sit around – or North Korea – he wouldn't sit around saying 'Well, I would like to respond, but Congress just will not write that bill.' He'd say 'No, I am the commander in chief, I have the power to defend against an invasion. We're being invaded.'"

Colter added that other than entitlements, "90 percent of all federal money is in the Department of Homeland Security and the Department of Defense, and this [border security] is both homeland security and defense."

"Did he have to get a special bill when we bombed Syria?" asked Coulter. "By mistake, it turned out. No, obviously there are discretionary funds there, and they don't need to be spent just to send off bombs to make Boeing even richer than they already are for no purpose at all."

"Of course you can build a wall," she added later. "That is most of what the military did for the first 100 years. We weren't going around remaking the rest of the world. It was the military building forts on our border. Defending American borders is the number one job of the commander in chief."
