American Action Forum (AAF), a conservative non-profit run by former Congressional Budget Office (CBO) director Douglas Holtz-Eakin, released a study on Monday which found that Ocasio-Cortez's Green New Deal could cost somewhere between \$51 and \$93 trillion over the next ten years.

America's current national debt [surpassed](#) \$22 trillion this year, which means the Green New Deal could cost more than four times the national debt.

"The Green New Deal is clearly very expensive," AAF [said](#) in its report. "It's further expansion of the federal government's role in some of the most basic decisions of daily life, however, would likely have a more lasting and damaging impact than its enormous price tag."

AAF wrote that the Green New Deal figure includes between \$8.3 trillion and \$12.3 trillion to meet the climate activists' plan to eliminate carbon emissions from the power and transportation sector, and \$42.8 and \$80.6 trillion for its economic agenda, which will provide jobs and health care for every American.

Climate activists suggest that not acting on climate change may become more expensive than the plan. Ocasio-Cortez and Sen. Ed Markey's (D-MA) plan referenced a United Nations report which said that catastrophic climate change could cost more than \$500 billion annually in lost economic output by 2100.

Markey tweeted on Monday that the study had "artificially inflated" the cost of the Green New Deal.

Markey wrote, "Any so-called "analysis" of the [#GreenNewDeal](#) that includes artificially inflated numbers that rely on lazy assumptions, incl. About policies that aren't even in the resolution is bogus. Putting a price on a resolution of principles, not policies, is just Big Oil misinformation."

Ocasio-Cortez questioned on Sunday whether people should stop having children to combat climate change.

"Our planet is going to hit disaster if we don't turn this ship around and so it's basically like, there's a scientific consensus that the lives of children are going to be very difficult," Ocasio-Cortez [said](#). "And it does lead, I think, young people to have a legitimate question, you know, Is it okay to still have children?"

In January, the New York progressive suggested that the world will

end in 12 years if the world does not address “climate change.”

## **RoundUp Weed Killer Found in 19 Out of 20 Leading Beer and Wine Brands in the US**

RoundUp, the pesticide that contains the controversial ingredient glyphosate that has been linked to cancer, was detected in 19 out of 20 leading alcoholic beverages that were tested. The beer brands included Coors Light, Miller Lite, Budweiser, Corona, Heineken, Guinness, Stella Artois, New Belgium, Sierra Nevada and Samuel Adams, and the wine brands were Beringer, Sutter Home, Barefoot, Inkarri and Frey Vineyards. The levels detected were below limits set by the Environmental Protection Agency, but critics still believe it is harmful. Bayer, which now owns RoundUp manufacturer Monsanto, is currently facing some 9,300 lawsuits alleging that its popular glyphosate-based weed killer RoundUp.

## Traces

of a controversial weed killer have been detected in a number of the world's leading beer and wine brands, a new report claims.

## In

a study by public-interest advocacy group US PIRG that tested five wines and 15 beers, including organic ones, the chemical glyphosate was found in all but one of the beverages sampled.

## Glyphosate

– the most common herbicide in the world and an ingredient in the weed killer Roundup – is a probable human carcinogen, according to

the  
International Agency for Research on Cancer, part of the World  
Health  
Organization.

The report acknowledged  
that the levels detected were below limits set by the  
Environmental  
Protection Agency, but PIRG the results warrant some degree of  
public  
concern.



## PayPal CEO Admits Partnering with Far-Left SPLC to Blacklist Conservatives

PayPal CEO Dan Schulman admitted that his company works with the radical Southern Poverty Law Center when it considers blacklisting conservatives. PayPal has blacklisted WikiLeaks, Infowars, Gavin McInnes, Tommy Robinson, Lauren Southern, Laura Loomer, Roosh V, free speech social network Gab and Youtube competitor Bitchute. The SPLC, which also reportedly works with Amazon, Google, Facebook, and Twitter, was forced to pay a \$3.3 million settlements to Maajid Nawaz, an activist against Muslim extremism.

PayPal CEO Dan Schulman admitted during an interview with the *Wall Street Journal* that PayPal works with the far-left Southern Poverty Law Center (SPLC) when it considers blacklisting conservatives.

After being asked by the [Wall Street Journal](#) what “values” PayPal identifies with,” Schulman replied, “Probably the most important value to us is diversity and inclusion.”

“I think North Carolina was probably the moment that was the most visible, where we basically said this violates our core value and we need to make a very public stand on it,” claimed Schulman, referencing the time when PayPal [pulled](#) out of an investment in North Carolina because the state passed a bill making it mandatory for people to use the bathroom of their biological sex.

“Businesses need to be a force for good in those values and issues that they believe in. It shouldn’t come from backlash or people taking heat on it, because then it’s in response, as opposed to the definition of who you are and then how you react to the context that you find yourself in,” the PayPal CEO expressed, adding that the Charlottesville rally in 2017 was a “defining moment” for PayPal to start blacklisting conservatives.

Schulman claimed it “was a defining moment for us as a company,” that was “difficult,” because, “the line between free speech and hate, nobody teaches it to you in college. Nobody’s defined it in the law.”

During the interview, Schulman also admitted that the far-left SPLC helps to inform “PayPal’s decisions.”

“There are those both on the right and left that help us. Southern Poverty Law Center has brought things. We don’t always agree. We have our debates with them. We are very respectful with everyone coming in. We will do the examination carefully,” Schulman explained. “We’ll talk when we don’t agree with a finding: We understand why you think that way, but it still goes into the realm of free speech for us.”

The SPLC, which also reportedly [works](#) with Amazon, Google, Facebook, and Twitter, was forced to [pay](#) a \$3.3 million settlements to anti-extremist activist Maajid Nawaz last year, after the organization included him on a list of “anti-Muslim extremists,” despite Nawaz being Muslim himself.

# Federal Judge Rules Male-Only Military Draft Is Unconstitutional

Texas: US District Judge Gray Miller, a George W. Bush appointee, ruled in favor of a men's rights group, declaring that the male-only military draft is unconstitutional. In 1981, the Supreme Court ruled that the all-male draft was "fully justified" because women could not fulfill combat roles, however, Judge Miller said that the discrimination may have been justified in the past, but men and women are now equally able to fight.

**Draft our daughters.**

A federal judge in Texas ruled late Friday that the male-only military draft is unconstitutional, declaring that "the time has passed" for a debate whether women belong in combat.

US District Judge Gray Miller, a George W. Bush appointee, dealt a huge blow to the current Selective Service System since the SCOTUS

upheld the draft in a 1981 ruling.

In *Rostker v. Goldberg*, the Supreme Court ruled that the all-male draft was “fully justified” because women could not fulfill combat roles.

USA Today [reported](#):

*U.S. District Judge Gray Miller ruled late Friday that while historical restrictions on women serving in combat “may have justified past discrimination,” men and women are now equally able to fight. In 2015, the Pentagon lifted all restrictions for women in military service.*

*The case was brought by the National Coalition For Men, a men’s rights group, and two men who argued the all-male draft was unfair.*

*Men who fail to register with the Selective Service System at their 18th birthday can be denied public benefits such as federal employment and student loans. Women cannot register for Selective Service.*

*The ruling comes as an 11-member commission is studying the future of the draft, including whether women should be included or whether there*

*should continue to be draft registration at all.*

*The National Commission on Military, National and Public Service*

*released an interim report last month giving no hints on where it would*

*come down on those questions. But, commission chairman Joe Heck told USA*

*TODAY, "I don't think we will remain with the status quo."*

The lawyer representing the two men who brought the lawsuit said,

"Either they need to get rid of the draft registration, or they need to require women to do the same thing that men do."

Gray Miller's ruling was a declaration, not an injunction which means

the court did not specifically say how the government should change the

Selective Service System, USA Today reported.

The left has been pushing to put women in all-male combat units for years.

# **US Judge Says Prosecutors Violated the Rights of Victims in Jeffrey Epstein Underage Sex Abuse Case. Trump's Sec'y of Labor and Robert Mueller Are Under Fire.**

US District Judge Kenneth Marra ruled that in 2008, federal prosecutors in Florida violated the rights of victims by secretly reaching a non-prosecution agreement with wealthy financier, Jeffrey Epstein, who was accused of sexually abusing at least 60 of underage girls and recruiting them for prostitution. Epstein spent a mere 13 months in jail, paid financial settlements to victims and is a registered sex offender. The prosecutors failed to consult with the victims when negotiating the non-prosecution agreement, in violation of federal law. Judge Marra failed to overturn the agreement asked prosecutors and victims' lawyers to recommend in 15 days how to move forward, giving the guilty parties time to settle with the victims.

The Justice Department recently opened a separate investigation into the handling of the Epstein case to

determine whether prosecutors committed professional misconduct. Alexander Acosta was the US attorney in Miami at the time and brokered the deal. He now sits in Trump's cabinet and is his Secretary of Labor. Special counsel Robert Mueller led the FBI when the deal was brokered and also has culpability.

There is a two-tier justice system, one for wealthy and politically connected that allows them to evade accountability and punishment, and another for the public that denies justice for victims.

Pockets of the Future: Robert Mueller, Jeffrey Epstein and the FBI Connection

Ten years after convicted [Palm Beach sex offender Jeffrey Epstein](#) escaped federal charges in connection with allegations that he [paid dozens of teenage girls for sex](#), the FBI last week released what appears to be an explosive explanation for what many have long described as a sweetheart deal.

"Epstein has also provided information to the FBI as agreed upon,"

agents wrote  
in one of dozens of heavily redacted, decade-old memos that  
were  
unexpectedly and inexplicably posted on an FBI website known  
as “The  
Vault.”

The simple declaration stunned those who have been  
following the tortuous and celebrity-studded case for years.  
It  
rekindled talk that the billionaire’s 2008 decision to plead  
guilty to  
state charges to make the federal investigation disappear was  
part of a  
cover up to protect [Epstein’s high-powered friends, including  
President Donald Trump, former President Bill Clinton and  
Britain’s Prince Andrew.](#)

“That  
sentence obviously means something but I, too, am at a loss as  
to what  
it really means,” said attorney Brad Edwards, who for a decade  
has been  
trying to unravel the mystery of Epstein’s plea deal. “If  
there was some  
cooperation I would have expected that we would have been  
told.  
However, nothing surprises me at this point.”

In  
recent years, federal prosecutors have offered various  
explanations for  
why they agreed to drop the case they were building against  
the

65-year-old enigmatic money manager if he pleaded guilty to state prostitution charges. In court papers, they have said they wanted to get justice for Epstein's young victims but worried a jury wouldn't believe them.

So, they have said, they negotiated a deal, allowing Epstein to plead guilty in Palm Beach County Circuit Court to one count of soliciting a minor for prostitution and another charge of soliciting prostitution. In exchange, federal prosecutors agreed to close their investigation. They have said they had no idea Epstein would only serve 13 months of an 18-month sentence in a vacant wing of the county stockade – a cell he was allowed to leave 16 hours a day, six days a week.

While voicing dismay at his lax punishment, prosecutors have pointed out that the plea deal required Epstein to pay the roughly 30 young women who filed civil lawsuits against him. Further, they said his guilty pleas force him to register as a sex offender for the rest of his life, potentially protecting other girls from abuse in the future.

However, over the years, they have never suggested that

Epstein provided them any information in return.

Like Edwards, two people close to the long-closed federal investigation said they were flummoxed by the sentence in the FBI's memo that was written in September 2008, roughly two months after Epstein pleaded guilty in state court.

"I have never, ever heard of Jeffrey Epstein cooperating in any sense of the word," said one official, who requested anonymity because of the top role the person played in the investigation. "I am stumped. It's totally out of left field."

Another individual with ties to the case voiced similar views. Epstein may have been required to talk to FBI agents but it's unlikely he offered anything that would incriminate others, said the person, who declined to be identified because of ongoing efforts to help Epstein's victims challenge the plea deal. "I don't think he ever told the truth," the person said.

# Venezuela: Opposition Leader Juan Guaidó Has Ties with the CIA and Blood on His Hands. He Meets with VP Mike Pence Today.

Opposition Leader Juan Guaidó, who declared himself President with the support of the US, Canada, and Europe, trained with an elite team in Serbia to overthrow the government using student shock troops and weaponized protests. He has ties with the CIA and is linked to a number of violent operations, which have made his party, 'Popular will' unpopular, with less than 20% support.

Guaidó is meeting with Vice President Pence today at the Lima Group summit supporting the ouster of Maduro.

The *Greyzone Project* published an article on Juan Guaidó, who declared himself the President of Venezuela. He leads 'Popular Will', the most violent faction of Venezuela's opposition

party. His party, however, has less than 20% support because of its violent tactics.

.

In 2005, five Venezuelan student leaders trained in Serbia to bring about a revolt that eventually toppled Slobodan Milosevic. They used a revolutionary model that uses student shock troops to weaponize protests as a hybrid form of warfare. The movement is funded by the National Endowment for Democracy, a CIA front group, and is deployed against regimes that are not compliant with US objectives.

In 2010, 'Popular Will' exploited a severe drought that affected electrical output and caused discontent. At this same time, it and other opposition groups were receiving \$40-50 million a year from US government organizations like USAID and the National Endowment for Democracy, according to a Spanish think tank. President Trump appointed Elliot Abrams as special US envoy to Venezuela. This stoked fears of a bloody proxy war, because Abrams is the convicted Iran-Contra felon who oversaw arming right-wing death squads during the 1980's in Nicaragua, El Salvador, and Guatemala.

Vice President Mike Pence has been involved in the overthrow of Maduro since before December 2018 when he called to affirm his support for Guaido who organized mass protests against Maduro following his victory in the election.

.

Guaido is meeting with VP Mike Pence on Monday as part of a summit with the Lima Group, a meeting of 12 American states which have recognized Guaido as the "legitimate" leader of Venezuela.

.

Over the weekend, at least four people were killed and many more injured in clashes at the border, blockaded by Maduro's military, as the US tried to deliver humanitarian aid. Three aid trucks caught fire at the Colombian border. In the town

of Santa Elena de Uairén, pro-government armed gangs and national guard members took to the streets to try and disperse opposition supporters. Sixty members of Maduro's security force defected, but it was not enough to deliver the aid. Caracas has reportedly allowed in hundreds of tons of Russian and other international aid and supplies.

Venezuela's Foreign Minister Jorge Arreaza blamed Secretary of State and former CIA boss Mike Pompeo for staging a false flag when a truck carrying US aid was burned.

Maduro says US aid was meant to destabilize his government as military transport planes have been landing in US ally Colombia airstrips, as part of broader efforts provoke a coup.

Secretary of State Mike Pompeo told Fox News that Maduro regime's days are "numbered" and that "every option" is on the table toward making that happen.

## **Democrat Kamala Harris Calls for Slavery Reparations While She Is a Descendant of a Jamaican Slave Owner**

Last week, Kamala Harris voiced her support for reparations for slavery of blacks, which ended over 150 years ago, calling for vague changes in policies policies and structures. Kamala's father, Donald Harris, a retired professor of economics at Stanford University, wrote that his paternal grandmother, Christiana Brown, was a direct descendant of Hamilton Brown, a Northern Irish Protestant plantation owner who owned slaves. While Kamala's family may have been produced from Hamilton forcing himself on one of the slave women, Donald Harris' reported that Christiana Brown carried the same name as Hamilton Brown and owned a general store in town while her sons worked the family farmland at Orange Hill. They profited from the family name, making them culpable for any suffering of slaves who worked the plantation, if the left follows its own standards by blaming current generations for sins committed by ancestors who passed long ago. Critics are waiting for her to be the first to pay reparations.

Sen Kamala Harris (D-Calif) is on the record as backing "some

form of reparations” for slavery. [In a recent interview](#), Harris agreed with the host’s suggestion that government reparations for black Americans were necessary to address past discrimination. The 2020 presidential hopeful later “affirmed that support” in [a statement to The New York Times](#).

“We have to be honest that people in this country do not start from the same place or have access to the same opportunities,” she said in an interview with “The Breakfast Club.”

Harris continued:

*Well look, I think that we have got to address that again, it's back to the inequities. There, through—look, America has a history of 200 years of slavery. We had Jim Crow. We had legal segregation in America for a very long time. The Voting Rights Act was only strong for 50 years and then they wiped it out with this United States Supreme Court in the Shelby decision, to the point that 22 states immediately thereafter put in place laws that one court found were crafted with surgical precision to have black people not be able to vote.*

*So we've got to recognize, back to that earlier point, people aren't starting out on the*

same base,  
in terms of their ability to succeed and so we have got to  
recognize  
that and give people a lift up. And, there are a number of  
ways to do  
it. Part of my initiative again around the "Lift Act" is that  
same  
point—you lifting people up who are making less than a  
hundred thousand  
dollars a year. What I want to do about rent is the same  
thing. What we  
need to do around education and understanding disparities,  
what we need  
to do around HBCUs. But we have a history of racism in  
America.

Harris doesn't owe anyone in America, but does she have some  
*mea culpas* to make in Jamaica? Her father, [Donald  
J. Harris, wrote an extensive essay about the family's  
heritage in  
Jamaica at Jamaican Global Online in January, claiming to be  
the  
descendant of a famed slave owner.](#)

*My roots go back, within my lifetime, to my paternal  
grandmother Miss  
Chrishy (née Christiana Brown, descendant of Hamilton Brown  
who is on  
record as plantation and slave owner and founder of Brown's  
Town) and to  
my maternal grandmother Miss Iris (née Iris Finegan, farmer  
and  
educator, from Aenon Town and Inverness, ancestry unknown to  
me). The*

*Harris name comes from my paternal grandfather Joseph Alexander Harris, land-owner and agricultural "produce" exporter (mostly pimento or all-spice), who died in 1939 one year after I was born and is buried in the church yard of the magnificent Anglican Church which Hamilton Brown built in Brown's Town (and where, as a child, I learned the catechism, was baptized and confirmed, and served as an acolyte).*

## **Hamilton**

Brown was born in 1776 in Ireland. He became a sugar plantation owner and founder of Brown's Town in Jamaica, according to university papers, textbooks, and historical documents. [Henry Whiteley wrote a pamphlet entitled "Three months in Jamaica in 1832, Comprising a Residence on a Sugar Plantation,"](#) where he describes Brown's views on his slaves:

*The same day I dined at St. Ann's Bay, on board the vessel I arrived in, in the company with several colonists, among whom was Mr. Hamilton Brown, representative for the parish of St. Ann in the Colonial Assembly... I was rather startled to hear that gentleman swear by his Maker that that Order should never be adopted in Jamaica; nor would the planters of Jamaica, he said, permit the interference of the Home*

*Government with their slaves in any shape. A great deal was said by him and others present about the happiness and comfort enjoyed by the slaves, and the many advantages possessed by them of which the poor in England were destitute. Among other circumstances mentioned in proof of this, Mr. Robinson, a wharfinger, stated that a slave in that town had sent out printed cards to invite a part of his negro acquaintance to a supper party. One of these cards was handed to Mr. Hamilton Brown, who said he would present it to the Governor, as a proof of the comfortable condition of the slave population.*

But later that day, after he witnessed slaves being punished by Brown's overseer...
