



Tens of Thousands of Unopened Bottles of Water Supplies for Puerto Rico Hurricane Victims Was Discovered Rotting in a Field

Hurricanes Maria and Irma struck Puerto Rico in September 2017, resulting in the deaths of 3,000 people. Nearly two years after the disaster, tens of thousands of plastic bottles of water on pallets were discovered in a field. FEMA says the bottles were delivered in 2017 and turned over to the “central government.” It is unclear why the water was abandoned and who is responsible for failing to distribute it to those who needed it. Last month, prosecutors charged six former officials of the Puerto Rican government with embezzling \$15-million in hurricane reconstruction money. A local told CBS News “that the government hid those packages [of water] from the people,” adding that many were forced to purchase overpriced water from stores in the wake of the storms. Many people died of dehydration and disease from polluted water in the hurricane’s aftermath.

Last year, there was a similar case of wasted water in Puerto Rico: CNN reported that 20,000 pallets holding 38-million bottles of water were discovered to have been stored, instead of distributed. FEMA reported it delivered the water but it

was up to Puerto Rican officials to distribute it. Officials said they received too much water too late, and there was a surplus that they would return, even though there was still a need for clean water.

Tens of thousands of water bottles meant for the people of Puerto Rico after a pair of hurricanes hit the island in 2017 are sitting unopened on farmland near the city of San Juan nearly two years after the disasters.

Photographs of the water bottles emerged this week after international news agency AFP captured aerial images of the bottles on what appeared to be a private estate 25 miles west of San Juan. Some of the images showed broken pallets with the bottles.

A spokesman from the Federal Emergency Management Agency (FEMA) confirmed to AFP that the water bottles had been provided as part of relief for Hurricane Maria, which hit the island in September

2017.

The water was expired and it was assumed that the bottles are being disposed of, AFP reported. It said the spokesman declined to say exactly how many water bottles there were, how long they were on the farm and why they were permitted to expire.

The matters were “under review by the legal department,” the spokesman said.

Accused Frankfurt Train

Station Killer Was Praised as a Model Immigrant by Swiss NGO. More Train Murders Covered Up in Media.

Habte Araya, 40, an economic migrant from Eritrea but living in Switzerland, was arrested for pushing an 8-year old boy and his mother under a high-speed train at Frankfurt's main station. The boy was killed instantly. Araya is also accused of trying to push a 78-year old woman onto the tracks. The suspect fled but was tackled by passengers. He faces charges of murder and attempted murder. Araya was used in a 2017 campaign by a Swiss NGO as a poster boy for successful integration in Switzerland. The Swiss Workers Relief Agency (Schweizerischen Arbeiterhilfswerks), the NGO that promoted Araya, lobbies for open borders to bring in migrants who are likely to vote for socialism.

Just nine days earlier, a 34-year old mother was pushed in front of an oncoming train and murdered; a 28-year old Albanian Kosovar man was arrested in the west German town of Voerde. Last February in Nuremberg, three teenage boys were pushed in front of an oncoming train that left two of them dead. The accused murderers are both 17, and one is a Turk, and the other Albanian. The media tried to cover up the murders by claiming that the boys died in a tragic accident.

A REFUGEE who allegedly pushed an eight-year-old boy under a train in Frankfurt had been a poster boy for successful integration.

Habte Araya originally from Eritrea but living in Switzerland, has been arrested for shoving a boy and his mother under a locomotive in the German city.

Now it has emerged that the 40-year-old suspect was celebrated as a "prime example" of successful integration in his adopted home of Weadenswil, Switzerland,.

In 2017, he was even pictured in an advertising brochure from the Swiss Workers Relief Agency (Schweizerischen Arbeiterhilfswerks) as an example of successful integration, according to local media.

He gave an interview at the time saying that "he liked almost everything about Switzerland," adding: "When I first came communication was difficult because of the language.

"But that is no longer the case. I like the fact that everyone is helped here regardless of whether they are rich or poor.

"I want a better and easier life for my children than I had."

'RESERVED AND A BIT SHY'

Employees at the Swiss Workers Relief Agency where he worked as a

building fitter described Araya in local media as “reserved and a bit shy”.

He was described as a hard worker, not somebody who stands around talking and wasting time and they said he was “reliable”.

Araya arrived in Switzerland in 2006 and applied for asylum status which he was granted in 2008.

Witnesses described how Araya, a married father-of-three, pushed the boy and his mum onto the train tracks at Frankfurt Station before running away.

The mum, 40, survived the incident by rolling away from the tracks but the lad boy didn't make it.

New York Area Fire Commissioners Call for New 9/11 Investigation of “Pre-Planted Explosives”

New York: Five fire commissioners from Franklin Square and Munson Fire District, which oversees a volunteer fire department that performed rescue operations following the 9/11 attacks, passed a resolution calling for a new investigation into 9/11. The resolution says there is “overwhelming evidence” that “pre-planted explosives . . . caused the destruction of the three World Trade Center buildings.” Their goal is to get every fire district in the state to go on record supporting a new investigation. The US Attorney’s Office says it will present the petition to a special grand jury. -GEG

The Franklin Square and Munson Fire District 9/11 Resolution

Whereas, the attacks of September 11, 2001, are inextricably and forever tied to the Franklin Square and Munson Fire

Department;

Whereas, on September 11, 2001, while operating at the World Trade Center in New York City, firefighter Thomas J. Hetzel, badge #290 of Hook and Ladder Company #1, Franklin Square and Munson Fire Department of New York, was killed in performance of his duties, along with 2,976 other emergency responders and civilians;

Whereas, members of the Franklin Square and Munson Fire Department were called upon to assist in the subsequent rescue and recovery operations and cleanup of the World Trade Center site, afflicting many of them with life-threatening illnesses as a result of breathing the deadly toxins present at the site;

Whereas, the Board of Fire Commissioners of the Franklin Square and Munson Fire District recognizes the significant and compelling nature of the petition before the United States Attorney for the Southern District of New York reporting un-prosecuted federal crimes at the World Trade Center on September 11, 2001, and calling upon the United States Attorney to present that petition to a Special Grand Jury pursuant to the United States Constitution and 18 U.S.C. SS 3332(A);

Whereas, the overwhelming evidence presented in said petition demonstrates beyond any doubt that pre-planted explosives and/or incendiaries – not just airplanes and the ensuing fires – caused the destruction of the three World Trade Center buildings, killing the vast majority of the victims who perished that day;

Whereas, the victims of 9/11, their families, the people of New York City, and our nation deserve that every crime related to the attacks of September 11, 2001, be investigated to the fullest and that every person who was responsible face justice;

NOW THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of the Franklin Square and Munson Fire District fully supports a comprehensive federal grand jury investigation and prosecution of every crime related to the attacks of September 11, 2001, as well as any and all efforts by other government entities to investigate and uncover the full truth surrounding the events of that horrible day.
