



Blockbuster Investigation: 'The Trayvon Hoax' that Ignited Racial Division in America Was Based on a Spectacular Fraud

Filmmaker Joel Gilbert shows how Trayvon Martin's family's attorney, Benjamin Crump, recorded a conversation with Diamond Eugene, Trayvon's girlfriend who was on the phone with the Trayvon in the last moments of his life. Gilbert says Diamond's recorded statement with attorney Crump essentially consisted of her simply agreeing with the lawyer, who was creating a racial agenda. The recording ignited the public, swayed President Obama, gained support from LeBron James and the NBA, and ultimately provoked the nation's media to demand Zimmerman's arrest.

Diamond Eugene, who was being coerced by Travon's family, friends, and attorney, disappeared and never testified at Trayvon's trial. Instead, Rachel Jeantel, who claimed to be Diamond at the trial, was an impersonator.

Gilbert contends that the phone call would never overcome the physical evidence and eye witnesses that were in Zimmerman's favor, so the case was not about convicting him, but merely to get him arrested and into the news. The agenda to get Zimmerman into court was to mobilize black voters for Obama in 2012, as he was losing support in the black community prior to that.

Gilbert says that politicians and the media used the event to create the false impression that blacks are under threat of attack by white, Republicans.

Gilbert says that Trayvon's parents and their attorney knew about the witness imposter. He says the Florida state prosecutors, who withheld evidence from Zimmerman's attorneys and ignored Rachel Jeantel's confession, also knew of the criminal deception.

The arrest of Zimmerman allowed Trayvon's family to file a

lawsuit against the homeowners association, and they received a \$2-million pay-out. Trayvon's mother, Sybrina Fulton, now is a candidate for Dade County Commissioner in Miami.

Double Standard of Justice: Roger Stone Found 'Guilty' of Lying to Congress While Democrat Liars Evade Prosecution

Former Donald Trump campaign strategist, Roger Stone, 67, has been found guilty of all seven felony charges including lying to Congress, witness tampering, and obstruction, with regard to his contact with WikiLeaks. Prosecutors used Stone's own text messages and emails, some of which appeared to contradict his congressional testimony, to lay out their case that he lied to Congress and threatened a witness. Stone did not testify, and his lawyers called no witnesses in his defense.

Stone was not allowed by Judge Amy Berman Jackson, an Obama

appointee, to demand proof that Russia did indeed hack the DNC computers. Attorneys for Stone contended that if the Russians did not hack the DNC computers, the case against Stone would have had to be dismissed. Stone is under a court-imposed gag order forbidding him from speaking publicly about the verdict or the case until sentencing in February 6, 2020. He faces up to 50 years in prison.

Upon learning of the verdict, the President tweeted, "So they now convict Roger Stone of lying and want to jail him for many years to come. Well, what about Crooked Hillary, Comey, Strzok, Page, McCabe, Brennan, Clapper, Shifty Schiff, Ohr & Nellie, Steele & all of the others, including even Mueller himself? Didn't they lie?"

On Friday, Roger Stone, a political operative who had worked with Presidents Richard Nixon, Ronald Reagan and Donald Trump, was convicted by a federal jury on seven counts ranging from lying to Congress to obstruction of justice to witness tampering. His sentencing will take place on February 6, 2020, and Stone could face up to 50 years in prison.

Prosecutors argued that Stone pressured radio talk show host Randy Credico not to testify before the House Intelligence Committee, which was investigating Russian interference in the 2016 election. Stone claimed that Credico was his source for WikiLeaks information, but the talk show host later admitted he lied about his contacts. Credico boasted that he supplied investigative reporter Michael Isikoff "disinformation" and "phony emails" for a book about the investigation into Russian tampering with the 2016 election.

Credico is a liberal talk show host, who admitted after the verdict that he feels "horrible" that Stone may go to prison "because of me." Prosecutors targeted Stone for supposed efforts to gather information for the Trump campaign from

WikiLeaks about the hacking of Democratic National Committee (DNC) computers. Stone's defense team noted that he never established any connection with WikiLeaks, so he had no real information to provide to the campaign.

Stone was not allowed by Judge Amy Berman Jackson, appointed to the bench by former President Barack Obama, to demand proof that Russia did indeed hack the DNC computers. Federal prosecutors working with Special Counsel Robert Mueller contended that Russia accessed DNC computers and released damaging emails to thwart the presidential campaign of Hillary Clinton. Stone asked to see the report from CrowdStrike, a cybersecurity firm, that inspected the DNC computers and determined the Russians infiltrated their network. Attorneys for Stone contended that if the Russians did not hack the DNC computers, the case against Stone would have had to be dismissed.

Stone was convicted by a jury that convened in Washington D.C., a city where 96% of the voters supported Hillary Clinton in the 2016 presidential election. Stone joins other Trump associates such as former Campaign Chairman Paul Manafort, former National Security Adviser Michael Flynn, and former foreign policy aide George Papadopoulos who have faced prosecution. All of them were targeted by prosecutors working for former Special Counsel Robert Mueller.

While Stone, Manafort and other Trump operatives have been convicted, those working with the "Deep State" never seem to face any legal trouble. Former FBI Director James Comey and Associate Director Andrew McCabe clearly lied on multiple occasions, yet neither of them has faced any charges. Even though the Department of Justice Inspector General Michael Horowitz has made a criminal referral for McCabe, federal prosecutors at the U.S. attorney's office in Washington D.C., have not acted.

Hillary Clinton transmitted top secret information on her

“home brew” computer, yet she was not charged because former FBI Director James Comey maintained there was supposedly no “intent” to commit a crime. It remains to be seen how she could direct her phones to be destroyed by hammers and her computers to be wiped clean with “bleach bit” and there be no criminal intent.

Portland: Deranged Anti-ICE

Protester Sentenced To 3 Years In Prison After Attacking Disabled Man

An anti-ICE (Immigration and Customs Enforcement) protester, William Bryant Pierce, took a plea deal and a three year prison sentence after using a 6' flag pole to attack a 60-year old disabled man, jabbing at him through the window of his truck and striking him in the eye. According to court papers, Pierce told jailers that he uses THC daily and LSD intermittently. He said he was homeless and living off food stamps.

A local man said a Portland protester attacked him with a flagpole outside City Hall on Thursday.

The alleged assault occurred on Southwest 4th Avenue near City Hall just before 10:30 a.m., according to the Portland Police Bureau.

Police said the suspect, 33-year old Warren Pierce, was arrested and is facing an assault charge.

Officers said the pole was collected as evidence.

With a swollen and black eye, 60-year old Tim Schmitz spoke with FOX12 after being released from the hospital.

Schmitz said he may have a detached retina after an Abolish ICE protester jabbed him in the face, with what he believed was a 6-foot flag pole.

“He started coming at me through the window and started spearing me with the flagpole. I ducked it six or eight times and he finally got me the one time,” Schmitz said.

Schmitz said it all started when he was leaving City Hall, trying to make his way past a crowded sidewalk full of Abolish ICE protesters when he and one demonstrator began exchanging words.

Schmitz said he got in his truck to leave, pulled out to the street, where he stopped at a red light. That’s when he said the protester followed him, ran out into the street, and jabbed the flagpole through his truck window, striking his eye.

“I’m really disgusted with Portland. I’m disgusted and I feel ashamed that I even call it my birthplace. I know all about protesting and I understand it, I agree with. I don’t agree with stepping on my rights to do it though, especially because you don’t like what I say,” Schmitz said.

Emmy-Winning NBC Medical Correspondent, Bruce Hensel, Accused of Asking 9-Year-Old for Sex Pics

The Los Angeles Police Department arrested Dr. Bruce Hensel, 71, an Emmy-winning medical correspondent for NBC, after he allegedly asked a 9-year old girl for sexually explicit pictures. Hensel was released from custody later in the day after posting \$5,000 bond, and faces 18 months in prison if convicted.

An Emmy-winning former NBC medical correspondent has been accused of asking a nine-year-old girl for sexually explicit photos.

Authorities with the Los Angeles Police Department's Juvenile Division arrested Dr. Bruce Hensel, 71, on Wednesday morning for allegedly asking the girl for sexually charged pictures, KABC [reported](#).

Hensel was released from custody later in the day after posting \$5,000 bond.

The Los Angeles County District Attorney's Office said in a statement that Hensel was charged with one felony count of contact with a minor for sexual purposes.

Hensel allegedly asked the daughter of an acquaintance for the images using a messaging app on or about August 4, according to Deputy District Attorney Angela Brunson of the DA's Cyber Crimes Division.

Denver Business Owner Fined For Not Cleaning Up Feces And Used Drug Needles Left Behind by Homeless Vagrants

The city of Denver fined Jawaid Bayzar, a local internet business owner, after he and his staff refused to continue cleaning up after homeless people behind his building. He said that the homeless people leave trash, drug needles, food, and human waste in the alley where his business is located. He complained that the vagrants engage in drug deals, prostitution and violence. The city of Denver is following liberal policies and refuses to enforce laws against trespassing, camping, and public defecation. Denver contends that if the trash is on Bayzar's property, it is his responsibility to clean it. The city has threatened to issue additional fines, and Bayzar plans to fight the ticket in

court on December 18th.

The city of Denver fined a local business owner after he and his staff refused to continue cleaning up after homeless people behind his building, according to [CBS Denver](#).

“There’s food, trash, drug deals,” said Jawaid Bayzar, who added “In the alley we get, ya know, the defecation, drug needles, prostitution” behind his internet company, [Forethought.net](#). One night an employee was sitting in his car when someone smashed the window and tried to stab him, according to Bayzar.

And when Bayzar and his crew stopped cleaning up the constant hazardous mess left by the vagrants, telling *CBS* he’s not equipped to deal with it, Denver fined him.

“If the city’s not going to enforce laws against trespassing, or camping, or public defecation and just make me bare the cost of these problems that’s just not right,” he told *CBS4*.
