# California Democrats Pass Law to Protect Sex Offenders Who Have Homosexual Sex with Minors

California passed a law allowing an adult who has sexual relations with a child of the same sex, age 14 or older, to stay off of the sex-offender registry list if the sexual activity was “consensual” and the adult is less than 10 years older than the minor. Essentially, SB145 allows a 24-year old to have sex with a 14-year old and escape a felony conviction and the requirement to be a registered sex offender. Critics are concerned about children being groomed for sex abuse and they question whether 14-year old minors have the capacity to consent to sexual activity.

California’s Democrat Governor Gavin Newsom just signed Senate Bill 145, which lowers the penalties for adults who have sex with same-sex minors.

As Senator Melissa Melendez Tweeted, “Well what a shock. Newsom signed SB145, the bill that allows a 24 year old to have sex with a 14 year old and escape a felony conviction and requirement to be a registered sex offender. Absolutely disgusting.”

Last year California Globe reported that State Senator Scott

Wiener (D-San Francisco) and Assemblywoman Susan Eggman (D-Stockton) introduced legislation “to end blatant discrimination against LGBT young people regarding California’s sex offender registry.” Wiener and Eggman are members of the California Legislative LGBT Caucus.

If there are any lingering doubts about Sen. Wiener’s intent, the bill analysis is much more clear than Sen. Wiener:

“This bill states non-forcible sodomy, oral copulation, and sexual penetration with a minor do not require mandatory sex offender registration unless there is a ten-year gap between the minor and the other person. However, a court may still require registration if it deems appropriate. These offenses, when committed without force, where the minor was a willing participant and under the age of 14 are sometimes referred to as “Hofsheier offenses.” *People v. Hofsheier* (2006) 37 Cal.4th 1185 held that requiring mandatory sex offender registration for one such an offense – oral copulation – was unconstitutional if the state did not also require registration for a person convicted non-forcible sexual intercourse with a minor because it made an illegal distinction based on the sex act itself.”

“Non-forcible sodomy, oral copulation, and sexual penetration with a minor” is the first legal problem with this bill as it is against the law to have sex with a minor – gay or straight. The legal age of consent in California is 18 years of age. The age of consent refers to the age at which a person can legally consent to any sexual intercourse.

If there is a real inequity in the laws governing sex with minors, this bill is only undermining any sincere attempt to address that.

The definition of pedophilia according to Websters is “sexual perversion in which children are the preferred sexual object.”

Of the hundreds of comments left by California Globe readers, “normalizing pedophilia” was repeated over and over: “This is a push to normalize pedophilia which has always been the aim of some in the homosexual community.”

## **Supreme Court Justice Ruth Bader Ginsburg Has Died from Cancer. Democrats Threaten to Prevent Trump from Replacing Her.**

Supreme Court Justice Ruth Bader Ginsburg died on September 18 from cancer. President Trump is expected to nominate a new Justice to fill her seat before the elections on November 3rd. The Senate now has a slight Republican majority and the power to confirm a new appointee, but may lack the political will to do so. House Speaker Nancy Pelosi says she would not rule out impeachment as an option to stop President Trump's US Supreme Court pick from being confirmed, saying Democrats will “use every arrow in our quiver” to block the nominee. -GEG

Supreme Court pick from being confirmed to the bench, saying Democrats will “use every arrow in our quiver” to block the eventual nominee.

Just hours after it was announced that Supreme Court Justice Ruth Bader Ginsburg had passed away on Friday, Senate Majority Leader Mitch McConnell, R-Ky., vowed that a Trump nominee to the Supreme Court to fill her vacancy “will receive a vote on the floor of the United States Senate.”

During an interview on ABC News’ “This Week,” Pelosi, D-Calif., was asked whether she and House Democrats would move to impeach the president, or Attorney General Bill Barr in an effort to prevent the Senate from acting.

“We have our options. We have arrows in our quiver that I’m not about to discuss right now, but the fact is we have a big challenge in our country,” Pelosi said. “This president has threatened to not even accept the results of the election.”

She added: “Our main goal would be to protect the integrity of the election as we protect the people from the coronavirus.”

Pelosi was pressed again on whether she would employ impeachment tactics, to which she said the Constitution requires that Congress “use every arrow in our quiver.”

## **Louisville: Man Wearing 'Justice for Breonna Taylor' T-Shirt Arrested for Shooting 3 Men**

Louisville, Kentucky: Michael E. Rhynes Jr. was arrested on Saturday in the murder of three people, including two white men and one black man who were shot to death in a bar. Rhynes was wearing a 'Justice for Breonna Taylor' shirt at the time of the killing. Breonna Taylor was killed by Louisville Police during a "knock and announce" raid, during which her boyfriend shot at police. Rhynes is reported to have made several posts on social media in support of Black Lives Matter. The mainstream media appear to be ignoring this story because it runs counter to their narrative.

**A black male walked into a Louisville bar owned by a retired police officer and shot three random people at point blank range on Friday night – while wearing a Justice for Breonna Taylor shirt.**

*The suspect was smiling from ear to ear as he was arrested for the shooting at Bungalow Joe's Bar and Grill.*

Michael E. Rhynes Jr., 33, was arrested just after midnight Saturday after police found him crawling in brush near the restaurant, according to a report from WDRB.

The shooter was wearing a “Justice for Breonna Taylor” t-shirt. Naturally, the national media has completely ignored this story – which certainly would not have been the case if a mass shooter had been wearing a “Trump” shirt. Taylor became a Black Lives Matter martyr after being killed by Louisville Police during a “knock and announce” drug raid, during which her boyfriend shot at police.

## **Los Angeles Sheriff's Department Reported to Harbor 'Executioner' Rogue Officers**

A 'gang' of rogue officers at the Compton station, called the 'Executioners' and have matching skull tattoos, are accused of using violence, threats, and retaliation against other deputies, supervisors, and "members of the public" in order to strengthen the profile of the organization, and its influence at the station. A deputy reported the problem to Internal



Affairs, and instead of investigating it, IA gave the information to the gang who then responded with violence. The Executioners gang is believed to comprise as much as 40% of the Compton Sheriff's Department. African Americans and women are banned from becoming Executioners. The two LA Sheriff's deputies who were ambushed in their cruiser recently were from the Compton station and had only been on the job just over one year. The shooter has not yet been caught, despite the \$300,000 reward and massive amount of resources that could be deployed to find the gunman who may be a dwarf.

A county document listed dozens of cases since 1990 related to deputy gangs, including the Vikings, the Regulators, the Jump Out Boys, the 3000 Boys, and the Banditos that have led to nearly \$55 million in court judgments and settlements. And a number of cases are still pending.

Deputy Thomas Banuelos with the L.A. County Sheriff's Department says he endured five years of "bullying and intimidation" by members of a gang of deputies at the Compton sheriff's station known as the "Executioners."

"It was a very serious, violent and bloody assault which could have killed Deputy Banuelos," says the deputy's attorney Alan Romero. "He had him on the ground and was literally just bashing his head in with his elbow over and over and over again."

According to his government claim, Banuelos was told "under threat of violence" to go to meet with an alleged "enforcer" of the gang, Deputy Eugene Contreras. Banuelos suffered injuries to his head, but did not report the beating because Executioners warned him "not to cooperate with investigators and to lie about the violent attack," according to the claim.

"Deputy Contreras told Deputy Banuelos – if you open your mouth, you'll be labeled as no good, which essentially means that you're open for retaliation in the station by all members of the gang," says attorney Romero.

## **Nashville Officials Hid Low COVID-19 Cases in Bars and Restaurants and Continued Restrictions**

Leaked emails between the senior adviser to Nashville's Mayor and a health department official revealed that they tried to hide extremely low coronavirus cases, about 80 out of 20,000 cases, emanating from bars and restaurants, according to contact tracing data. The Mayor's senior advisor said that the data was "not for public consumption".

Nashville City Councilman Steve Glover said, "We raised taxes 34% and put hundreds, literally thousands, of people out of work that are now worried about losing their homes their apartments etcetera and we did it on bogus data. That should be illegal!"

## **Yelp Reveals 60% Of Business Closures Are Now Permanent**

Despite Washington DC and the Federal Reserve injecting more and more money into the real economy, creating unstable artificial growth, the economy has hit a road block. Yelp reported that 97,966 businesses, or about 60% of closed

businesses, will never reopen their doors again. Yelp notes restaurants, shopping and retail, and beauty and spas have been damaged the most with temporary and permanent closures since March 1. Professional services, like roofing, landscaping, accountants, and lawyers, experienced some of the smallest declines.

The virus pandemic shock is generating deep economic scarring, the likes of which many have never seen before. The virus-induced downturn has led the economy into a “liquidity trap,” in which interest rates will likely reside on the zero lower bound until 2023, and monetary policy could have trouble stimulating the real economy besides artificially inflating asset prices. As Washington pumps fiscal injection after fiscal injection into the real economy, creating unstable artificial growth, the latest lapse of fiscal support, now 46 days, has sent the economy into another slump.

For more color on the deep economic scarring, not just a deterioration in the labor market, we turn our attention to a Yelp report published Wednesday that revealed as of Aug. 31, 163,735 businesses have closed on the platform, a 23% increase since mid-July.

Yelp pointed out an increase of permanent business closures over the past six months, now reaching 97,966, or about 60% of closed businesses will never reopen their doors again.

*“As of August 31, 163,735 total U.S. businesses on Yelp have closed since the beginning of the pandemic (observed as March 1), a 23% increase since July 10. In the wake of COVID-19 cases increasing and local restrictions continuing to change in many states we’re seeing both permanent and temporary closures rise across the nation, with 60% of those closed businesses not reopening (97,966 permanently closed).”*
