



Iowa Man Sentenced to 15 Year in Prison for the 'Hate Crime' of Burning a LGBTQ Flag

Iowa: Adolfo Martinez, 30, was sentenced to more than 15 years in prison for a hate crime after lighting a local church's LGBTQ flag on fire. The maximum sentence for the hate crime was five years, but extra time was added because he was a repeat offender. He was also sentenced to one year in prison for reckless use of fire and was sentenced to another 30 days for harassment. GEG

An Iowa man will spend up to 16 years behind bars for stealing a pride flag from an Iowa church and setting it on fire – a sentence that even a local LGBTQ group says might be excessive, according to a new report.

Adolfo Martinez, 30, of Ames, was sentenced Wednesday for stealing the pride banner hanging at Ames Church of Christ back in June – and then burning it with lighter fluid and a lighter outside the Dangerous Curves Gentleman's Club, The Des Moines Register reported.

Martinez admitted he did it because he opposes homosexuality, and a jury convicted him last month, according to NBC News.

"I burned down their pride, plain and simple," Martinez told

local outlet KCCI back in June.

He was sentenced to 15 years for arson as a hate crime, one year for reckless use of explosives or fire and 30 days for harassment, according to the report.

Courtney Reyes, executive director of the statewide LGBTQ group One Iowa, told the network she appreciates how seriously the case was handled, but added the imposed sentence might actually be taking things too far.

Illinois Governor JB Pritzker Signed a Bill Requiring Schools LGBTQ Lessons in School. His Family Generously

Funds the Transgender Ideology.

Illinois Governor JB Pritzker signed a bill requiring schools to include the positive contributions of lesbian, gay, bisexual, and transgender individuals in their history curriculum. The lessons must be taught before students reach the eighth grade, and public schools in the state must include LGBT individuals in history lessons. Illinois is the fifth state to pass such a measure; the other states include California, Colorado, New Jersey, and Oregon. Governor Pritzker's family is worth approximately \$29-billion and is heavily invested in the medical industry. His cousin, James, is a transgender woman known as 'Jennifer,' who spends heavily to advance the institutionalization of transgenderism. His family also funds the ACLU and Planned Parenthood, which now are major voices in the transgender movement. -GEG

Illinois public schools will be required to teach about the contributions of LGBTQ people across the state and the country – under a new law approved by Gov. J.B. Pritzker.

The law, signed by Pritzker last week, mandates that the history curriculum in schools across the state include lessons spotlighting noteworthy lesbian, gay, bisexual and transgender Americans, according to the Chicago Tribune.

As part of the new curriculum – set to launch in 2020 – the LGBTQ-focused lessons must be taught before the students reach the eighth grade, according to the report.

All textbooks “must include the roles and contributions of all people protected under the Illinois Human Rights Act and must be non-discriminatory as to any of the characteristics under the Act,” the bill states.

California School District Will Not Allow Parents To Opt Children Out Of LGBTQ Content

California: Murietta School District will not allow parents to opt their children out of classes containing LGBTQ content. Strong objections arose when parents were shown a video featuring an ACLU staff member instructing teachers how to teach children about oral sex, masturbation, and same-sex relationships and how to help girls obtain abortions without parental knowledge. This is impossible because LGBTQ content is infused throughout the curricula, including history classes. Murrieta School District's Monica Gutierrez of the Public Information Office said that the California Healthy Youth Act requires teachers and curricula to "affirmatively recognize different sexual orientations, be inclusive of same-sex relationships, and teach students about gender identity and gender expression." -GEG

A California school district will not allow parents to opt their children out of classes containing LGBTQ content, figures or historical references, emails show.

Murrieta School District says parents have the ability to opt their children out of comprehensive sexual health, but parents are still not able to opt their children out of LGBTQ content when taught in other subjects, according to emails obtained by the Daily Caller News Foundation.

The district recently came under fire after a video from the conservative group Our Watch exposed progressive sex education programs in California teaching children about oral sex, masturbation, role-playing and more.

The video depicts ACLU staff attorney Ruth Dawson, according to Our Watch, instructing teachers on how to help students obtain abortions without parental consent. The video generated no local or national media coverage until a tipster alerted the DCNF.

An investigation by the DCNF found the California Board of Education implemented progressive sex and gender education curriculum in public schools across the state and that the ACLU was permitted to instruct California public school teachers on how to help children obtain abortions without parental consent.

Murrieta School District’s Monica Gutierrez of the Public

Information Office sent a July 29 email warning parents that misinformation was being spread throughout the district. President of Our Watch, Pastor Tim Thompson, said the misinformation Gutierrez was referring to was the Our Watch video and subsequent media coverage.

"I am writing to you this morning because the inaccuracies and false information regarding comprehensive sexual health education is once again propagating our community," Gutierrez wrote in an email to a group she referred to as "key communicators" obtained by the DCNF. She did not respond multiple requests for comment.

Gutierrez attached a pamphlet to the email, intended to distill rumors previously circulating in the community.

Thompson said he had proposed a model policy in a March email to the Murrieta School District that addressed concerns regarding LGBTQ content being taught to children. Gutierrez denied the request and told Thompson it was not possible for parents to opt their children out of LGBTQ content.

"We write in response to your request that the Murrieta Valley Unified School District ("District") mandate opt-out notifications in grades K-12 from discussions that mention LGBTQ content, figures, or historical references," Gutierrez wrote in a March 1 letter.

Gutierrez pointed out the California Healthy Youth Act, otherwise known as AB-329, mandates teachers and curricula "affirmatively recognize different sexual orientations, be inclusive of same-sex relationships, and teach students about gender, gender identity and gender expression."

"For all sexual health education, instruction and materials used in the District's sexual health and HIV education must be age appropriate, medically accurate, and appropriate for use with students of all races, genders, sexual orientations, and ethnic and cultural backgrounds, English learners, and

students with disabilities,” she continued.

The California Board of Education did not respond to multiple requests for comment on this mandate.

“In practice, this means that the above-mentioned criteria must be fused throughout the entirety of the curriculum,” Gutierrez added.

She said parents can opt their children out of the sex education courses but emphasized that California Healthy Youth Act has caused LGBTQ content to be included throughout a variety of courses and cannot reasonably allow parents to opt their children out of courses such as history.

Thompson told the DCNF he was moved to share pictures of Gutierrez’s emails on Facebook after the DCNF covered the Our Watch video.

“After your article stirred everything up, they told everyone the video was all lies,” he said. “That is when I decided to let everyone see the letter.”

Thompson explained children can be exposed to LGBTQ content in all areas of study, and that teachers will have the ability to use any books from the approved framework within the California Healthy Youth Act.

“The fact that the Murrieta Valley Unified School District continues to mislead parents by telling them that they can opt out infuriates me,” Thompson told the DCNF.

“They quote the opt out right pertaining to sex ed and never tell the parents that the LGBTQ content in other classes can not be opted out of. Everything they show the parents has to do with sex ed, and parents don’t know that these issues are now in history, language arts, assemblies, and the like.”

Thompson said the district policy is made very clear in the March letter he received and has since posted on Facebook. He added that Murrieta is not the only district doing this.

“Similar tactics of deceiving parents are deployed in districts around our state, and our nation. It’s time for parents to apply some very hard pressure to their respective school boards.”

Thompson said he attended a Thursday board meeting with the Murrieta School District where he called on the board to declare the district a “Sanctuary School District” for parental rights.

Style Gulags for 10 Years

Goldsmith's, University of London: The student group called Lesbian, Gay, Bisexual, Transgender, Queer Plus (LGBTQ+) Society suggested that people who question transgenderism should be sent to Gulags for ten years, for "re-education". Gulags were brutal labor camps used by Stalin's Soviet dictatorship to punish "enemies of the state", resulting in the death of more than a million people. Natacha Kennedy, a transgender lecturer at Goldsmiths, created a list of academics the student group wants to silence, and she ran a Facebook group calling for accusations of "hate crimes" to be used to silence them. The college suspended the group, but the organizers and members remain.

[Incidentally, LGBTQ+ organizers argued that Soviet Gulags weren't so bad as most people think, because death sentenced had been abolished, and the longest sentence was ten years. That's a very sick joke. They didn't need death sentences, because just about everyone who went to the Gulag died from exhaustion, illness, or malnutrition. The so-called ten-year sentences commonly were extended for another ten years upon the slightest provocation. A two-year sentence was considered by all to be a death sentence in fact.] -GEG

A leftist student group defended Stalin's Gulag labour camps Tuesday, calling them more "compassionate" than the "western, capitalist notion of prison".

The Lesbian, Gay, Bisexual, Transgender, Queer Plus Society at London's Goldsmiths University suggested people who question transgenderism are sent to such camps, for up to ten years, for "re-education".

"The ideas of [Trans exclusive radical feminists] and anti-Trans bigots literally *kill* and must be eradicated through re-education," the student group wrote on Twitter before

deleting their account.

When Claire Graham, a special education needs teacher, asked if their attempts to silence a list of academics who questioned transgenderism was “a bit fascist”, the account replied: “Na, we’ll just arrange to send you to the Gulag.”

Gulags were brutal labour camps used by Stalin’s Soviet dictatorship to lock up opponents and “enemies of the state”, resulting in the death of an estimated 1.05 million people.

The Twitter account claimed the CIA had spread “lies” about the Gulag system, adding:

“First myth to debunk: ‘u work until u die in Gulags!’ The Soviets did away with life sentences and the longest sentence was 10 years. Capital punishment was reserved for the most heinous, serious crimes.

“Queer Kid Stuff,” a YouTube channel geared toward teaching

The producer and host of “Queer Kid Stuff,” Lindsay Amer, created the channel in June 2016 to help children ages 3-7 better understand the LGBT community, according to the show’s website.

“Young queer people *need* to see themselves represented in their media and that is exactly what I aim to do,” Amer wrote.

In the videos, she and her co-host Teddy, a stuffed bear, invite guests on to explain various parts of the LGBT community, including the definitions of “gay,” “gender,” and “intersex.” They also discuss the subject of consent and include a sing-along video to go with it. Additionally, the channel discusses the Disney movie, “Frozen,” and how Elsa is allegedly homosexual.

In the latest video, Amer invites Jeff to explain the concept of drag queens to the kids. Following the pattern of every “Queer Kid Stuff” video, Teddy begins by asking the guest what his pronouns are and how he identifies.

Nasdaq Threatens 75% of Listed Companies, Demands Minorities Be Appointed to Directors to Board – Or Else

US stock exchange Nasdaq proposed new rules to the Securities and Exchange Commission (SEC) that will require all US companies listed on the exchange to publicly disclose diversity statistics regarding their board of directors, and most companies would have to either appoint “diverse” board members or explain why they hadn’t done so in a letter, or possibly face de-listing. Social media critics pointed out that selecting directors based on their skin color, genitalia and sexual preference epitomized the bigotry most “diversity” measures claim to fight. According to the New York Times, 75% of currently-listed Nasdaq companies fall short of the proposed requirements.

Goldman Sachs, also part of the woke progressive movement, will no longer take a company public unless it has at least one “diverse” board member. Since September, the state of California has required companies headquartered there to have a minimum number of minority directors or face six-figure fines. -GEG

US stock exchange Nasdaq has warned listed companies they must appoint at least two “diverse” directors to their board – a ‘self-identified’ female and an “underrepresented minority” or LGBTQ person – or possibly face delisting.

Nasdaq revealed its plan to turbocharge diversity on its exchange in a proposal filed with the Securities and Exchange Commission (SEC) on Tuesday.

Under the proposed new rules, not only will all listed US

companies be required to *“publicly disclose consistent, transparent diversity statistics regarding their board of directors,”* but *“most”* companies would have to either appoint *“diverse”* board members or explain why they hadn’t done so in a letter.

The mandatory addition of *“one [director] who self-identifies as female and one who self-identifies as either an underrepresented minority or LGBTQ+”* appears to leave room for Rachel Dolezal-style *“self-identification”* as something other than white, male, or straight – a potential loophole for companies that prefer to keep their current boards. Non-US companies and small firms would be permitted to appoint two female directors instead.

Listed companies would be required to publish their diversity stats within a year of the SEC adopting Nasdaq’s proposal, and be required to have *“one diverse director”* within two years of implementation. Depending on company size, they would have four or five years to comply with the two-director requirement. Those who fall short can escape delisting only *“if they provide a public explanation of their reasons for not meeting the objectives.”*

The *Vatican News* website [1] has reported the news that today at the Rome Film Festival a documentary film will be screened called *Francesco* made by director Evgeny Afineevsky.

This documentary – according to what has been reported by *Catholic News Agency*^[2] and *America Magazine*^[3] – makes public several pronouncements of Jorge Mario Bergoglio on the topic of homosexuality. Among the various statements, these two are

particularly disconcerting:

“Homosexuals have a right to be a part of the family. They’re children of God and have a right to a family. Nobody should be thrown out, or be made miserable because of it.”

“What we have to create is a civil union law. That way they are legally covered. I stood up for that.”

One does not have to be a theologian or a moral expert to know that such statements are totally heterodox and constitute a very serious cause of scandal for the faithful.

But pay careful attention: these words simply constitute the umpteenth provocation by which the “ultra-progressive” part of the Hierarchy wants to artfully provoke a schism, as it has already tried to do with the Post-Synodal Exhortation *Amoris Laetitia*, the modification of doctrine on the death penalty, the Pan-Amazon Synod and the filthy Pachamama, and the Abu Dhabi Declaration which has now been reaffirmed and aggravated by the Encyclical *Fratelli Tutti*.

It appears that Bergoglio is impudently trying to “raise the stakes” in a crescendo of heretical affirmations, in such a way that it will force the healthy part of the Church – which includes bishops, clergy, and faithful – to accuse him of heresy, in order to declare that healthy part of the Church schismatic and “the enemy of the Pope.”

Jorge Mario Bergoglio is trying to force some Cardinals and Bishops to separate themselves from communion with him, obtaining as a result not his own deposition for heresy but rather the expulsion of Catholics who want to remain faithful to the perennial Magisterium of the Church. A pronouncement by the bishops against Bergoglio on a question like homosexuality could potentially lead civil authority to prosecute them criminally, with the approval of the Vatican.

Bergoglio would thus have on his side not only the “deep church” represented by rebels like Father James Martin, S.J., and those who promote the German “Synodal Path,” but also the “deep state.” It is not surprising that in the documentary there is also an endorsement of the Democratic candidate in the upcoming American presidential election, along with a disconcerting condemnation of the policy of the Trump Administration, which is accused of separating families that want to enter the United States illegally, while the reality is that the President is confronting human trafficking and the trafficking of minors.

California Democrats Pass Law to Protect Sex Offenders Who Have Homosexual Sex with Minors

California passed a law allowing an adult who has sexual relations with a child of the same sex, age 14 or older, to stay off of the sex-offender registry list if the sexual activity was “consensual” and the adult is less than 10 years older than the minor. Essentially, SB145 allows a 24-year old to have sex with a 14-year old and escape a felony conviction and the requirement to be a registered sex offender. Critics are concerned about children being groomed for sex abuse and they question whether 14-year old minors have the capacity to consent to sexual activity.

California’s Democrat Governor Gavin Newsom just signed Senate Bill 145, which lowers the penalties for adults who have sex with same-sex minors.

As Senator Melissa Melendez Tweeted, “Well what a shock. Newsom signed SB145, the bill that allows a 24 year old to have sex with a 14 year old and escape a felony conviction and requirement to be a registered sex offender. Absolutely disgusting.”

Last year California Globe reported that State Senator Scott Wiener (D-San Francisco) and Assemblywoman Susan Eggman (D-Stockton) introduced legislation “to end blatant discrimination against LGBT young people regarding California’s sex offender registry.” Wiener and Eggman are members of the California Legislative LGBT Caucus.

If there are any lingering doubts about Sen. Wiener’s intent, the bill analysis is much more clear than Sen. Wiener:

“This bill states non-forcible sodomy, oral copulation, and sexual penetration with a minor do not require mandatory sex offender registration unless there is a ten-year gap between the minor and the other person. However, a court may still require registration if it deems appropriate. These offenses, when committed without force, where the minor was a willing participant and under the age of 14 are sometimes referred to as “Hofsheier offenses.” *People v. Hofsheier* (2006) 37 Cal.4th 1185 held that requiring mandatory sex offender registration for one such an offense – oral copulation – was unconstitutional if the state did not also require registration for a person convicted non-forcible sexual intercourse with a minor because it made an illegal distinction based on the sex act itself.”

“Non-forcible sodomy, oral copulation, and sexual penetration with a minor” is the first legal problem with this bill as it is against the law to have sex with a minor – gay or straight. The legal age of consent in California is 18 years of age. The age of consent refers to the age at which a person can legally consent to any sexual intercourse.

If there is a real inequity in the laws governing sex with minors, this bill is only undermining any sincere attempt to address that.

The definition of pedophilia according to Websters is “sexual perversion in which children are the preferred sexual object.”

Of the hundreds of comments left by California Globe readers, “normalizing pedophilia” was repeated over and over: “This is a push to normalize pedophilia which has always been the aim of some in the homosexual community.”
