



An American-Thai Couple Are in Deep Water Over Their Attempt to Establish a Community at Sea

The Royal Thai Navy plans to remove a house on a platform 12 miles off the coast of Phuket that was built by Ocean Builders to promote the concept of “seasteading,” which is the concept of permanent dwellings built at sea, outside the territory claimed by any government. The house was occupied by American Chad Elwartowski and his Thai partner Supranee Thepdet, who planned for others to join them in a libertarian-style community that they believed would be beyond legal jurisdictions. Thai authorities filed a complaint accusing the couple of breaching a section of the country’s criminal code that relates to threatening the sovereignty of a state, and erosion of a state’s independence – these charges carry a death penalty! The couple is now in hiding and Elwartowski says he fears for his life.

Chad Elwartowski and his Thai partner Supranee Thepdet, also known as

Nadia Summergirl, were reportedly living in the house, built by [Ocean Builders](#), to promote the concept of “seasteading.”

“Seasteading

is the concept of creating permanent dwellings at sea, called seasteads, outside the territory claimed by any government,” says the company on its website.

In a promotional video posted to [YouTube](#) in March, Elwartowski toasts his partner with champagne on the roof of their ocean dwelling. He says 20 more floating homes are planned so others can join them in a libertarian-style community that they believe will be beyond legal jurisdictions.

Governments “have a monopoly on land but they don’t have a monopoly at sea,” Elwartowski says in the video. “We’re looking forward to freedom-loving people to come join us out on the open ocean.”

In an [earlier video](#), he says international waters are “where there are no laws other than the law of the sea.”

But

Thai authorities have a different view. They have filed a compliant,

accusing the couple of breaching a section of the country's criminal code that relates to threatening the sovereignty of a state, and erosion of a state's independence, according to the *Post*. The charges carry [the death penalty](#).

London: UK Government Arrests Julian Assange from the Ecuadoran Embassy in Response to Pressure from US

Julian Assange of WikiLeaks was arrested at the request of the US government on a charge of agreeing to break a password to a classified US government computer. He has been living in the Ecuadoran embassy in London since 2012 where he was granted asylum. Ecuador's President Lenin Moreno is the subject of the

'INA Papers' that were leaked in February that are said to link him and his family to money laundering. WikiLeaks did not publish the INA Papers but did report that Moreno was under investigation for corruption. Last December the New York Times revealed that Moreno tried to sell Assange to the US for debt relief. Ecuador received \$4.2 billion in a US backed IMF bailout on February 4. The US seeks Assange's extradition over WikiLeaks' 2010 shocking internal documents on war and diplomacy.

On 26 March, WikiLeaks' Twitter account announced that President Moreno is being investigated by Ecuador's Congress for corruption, sparked by the INA Papers leak. The same tweet referenced President Moreno's attempt to surrender Assange in exchange for US debt relief, a fact that had been [reported](#) by *The New York Times*.

The following day, [Foreign Minister Jose Valencia said](#) that the WikiLeaks tweet was "an absurd lie to harm the dignity of our country... we will not tolerate... inventions and insults... I cannot anticipate when and when we will take action in relation to this, but we will take action for certain."

On 28 March, [Communications Minister Andrés Michelena told CNN Español](#) that the INApapers were part of a plot of Julian Assange, Venezuelan President Maduro and former Ecuadorian President Correa to bring down Moreno's government. He added, "You have to understand how these people are connected, Mr. Assange is the Troll Center, the hacker for

former

President Correa, [Assange] handles the technological and social media side.”

That same day, the national assembly, in which Moreno’s party and other right parties command a majority, [passed a resolution](#)

inviting the Foreign Ministry to take action against Assange’s asylum

on the basis of the INApapers leak “in the national interest” if it

considers it pertinent to do so.

In March 2019, [Moreno’s approval ratings dropped to 17%](#).

Statements by the government of Ecuador deliberately implicate WikiLeaks in the INApapers leak. For example, Ecuador’s Vice President

Otto Sonnenholzner said in a local radio [interview](#), “What Wikileaks and other political actors have done, to publish private

photos of the President of the Republic, of his family, is a despicable,

repugnant, and odious act.”

Canada: Christian Activist Ordered to Pay \$55,000 to Transgender 'Woman' Activist in Precedent-Setting Case

Canada: The British Columbia Human Rights Tribunal ordered Christian activist, William Whatcott, to pay a fine of \$55,000 to Morgane Oger, a male who transitioned into a woman and then was defeated in a local election. Whatcott's flyers, distributed in Oger's voting district, characterized the candidate as a "biological male" who was promoting "homosexuality and transvestism." The flyer also advocated rejecting Oger in favor of "God's definition of gender and marriage." Oger claimed that the flyer was intended to provoke hatred. Whatcott said his flyers were an act of religious expression. Whatcott had distributed flyers in a previous case, and they were ruled by the Supreme Court of Canada to be hateful. Whatcott says he will continue to distribute flyers and that he has no intention of paying the fines ordered by the tribunal because he doesn't have the money and because he wouldn't do so even if he had it.

The B.C. Human Rights Tribunal has ordered Christian activist William Whatcott to pay \$55,000 to trans activist Morgane Oger.

Tribunal

member Devyn Cousineau said \$35,000 was compensation for a hate-filled flyer that Whatcott published when Oger was running for provincial office in 2017, and \$20,000 was to punish Whatcott for improper conduct during the five-day hearing in December.

According to the tribunal

ruling, Whatcott printed 1,500 of the flyers and distributed them in

the Vancouver-False Creek riding that Oger was contesting as an NDP

candidate. The flyer had a photo of Oger, described her as a "biological male" and claimed she was promoting "homosexuality and transvestism."

It went on to state transsexuals were prone to sexually transmitted

diseases and at risk of domestic violence, alcohol abuse and suicide.

The flyer concluded, "Thankfully Jesus Christ paid the price for your sin. You can turn to the merciful Christ and ask for forgiveness and when the NDP come knocking at your door you can tell them, you wont vote for them because you believe in God's definition of gender and marriage."

Oger, who lost the election by 400 votes, took the matter to the

tribunal, claiming her human rights had been breached because the flyer

was intended to discriminate and expose Oger to hatred.

Whatcott claimed
what he wrote in the flyer was an act of religious expression.

In
the ruling, Cousineau described a five-day hearing during
which
Whatcott was wearing a white T-shirt with Oger's face on it,
and
derogatory statements written underneath.

"In the hearing room for
this complaint, we were witness to repeated, deliberate and
flagrant
attacks on Ms. Oger based on nothing more than a belief that
her very
existence is an affront," Cousineau wrote, adding Whatcott
continued to
call Oger "he" and "mr" during the course of the hearing,
despite being
told not to.

Whatcott told the hearing that he produced the flyer after
praying to God to ask how he could help in the election.

Facebook Bans All 'Praise, Support, and Representation of White Nationalism and Separatism' Following the New Zealand Shooting Event

Facebook announced they'll be banning all "praise, support, and representation of white nationalism and white separatism" on Facebook and Instagram. Other race-based nationalist and separatist movements will not be banned. The government of Australia is threatening to pass laws that would jail social media executives if they fail to quickly remove 'extremist' material from their platforms, but the definition of extremist is expected to be biased in favor of collectivist ideology. Canadian Prime Minister Justin Trudeau also threatened to force social media companies to ban "hateful" and "extremist" content. -GEG

Facebook

on Wednesday announced they'll be banning all "praise, support and

representation of white nationalism and white separatism" on Facebook

and Instagram but will still allow other race-based nationalist and separatist movements.

Facebook had [said previously](#) they were against banning white nationalism and white separatism because they felt that under the same rules they'd also have to ban Zionism and black separatism.

Facebook's statement [reads](#):

Today we're announcing a ban on praise, support and representation of white nationalism and white separatism on Facebook and Instagram, which we'll start enforcing next week. It's clear that these concepts are deeply linked to organized hate groups and have no place on our services.

Our policies have long prohibited hateful treatment of people based on characteristics such as race, ethnicity or religion – and that has always included white supremacy. We didn't originally apply the same rationale to expressions of white nationalism and white separatism because we were thinking about broader concepts of nationalism and separatism – things like American pride and Basque separatism, which are an important part of people's identity.

But over the past three months our conversations with members of civil society and academics who are experts in race relations around the world have confirmed that white nationalism and white separatism cannot be meaningfully separated from white supremacy and organized hate groups. Our own review of hate figures and organizations – as defined by our [Dangerous Individuals & Organizations policy](#) – further revealed the overlap between white nationalism and white separatism and white supremacy. Going forward, while people

will still be able to demonstrate pride in their ethnic heritage, we will not tolerate praise or support for white nationalism and white separatism.

We also need to get better and faster at finding and removing hate from our platforms. Over the past few years we have improved our ability to use machine learning and artificial intelligence to find material from terrorist groups. Last fall, we started using similar tools to extend our efforts to a range of hate groups globally, including white supremacists. We're making progress, but we know we have a lot more work to do.

Our efforts to combat hate don't stop here. As part of today's announcement, we'll also start connecting people who search for terms associated with white supremacy to resources focused on helping people leave behind hate groups. People searching for these terms will be directed to [Life After Hate](#), an organization founded by former violent extremists that provides crisis intervention, education, support groups and outreach.

Unfortunately, there will always be people who try to game our systems to spread hate. Our challenge is to stay ahead by continuing to improve our technologies, evolve our policies and work with experts who can bolster our own efforts. We are deeply committed and will share updates as this process moves forward.

Wednesday that the new policy “doesn’t change the company’s existing policies on separatist and nationalist movements more generally; content relating to Black separatist movements and the Basque separatist movement, for example, will still be allowed.”

Independent journalist Nick Monroe noted this is the first time he’s seen a “race-based social media policy.”

Rockland County in New York Has Banned Unvaccinated Children from Public Places, Including School

Rockland County in New York declared a 30-day State of Emergency over an outbreak of measles, and anyone under 18 years of age and not vaccinated against measles will be barred from public places, including schools, stores, and houses of

worship, until they receive the MMR triple vaccine (mumps, measles and rubella). Six-thousand children have been ordered to stay home from school and away from public places. The measles outbreak has affected about 150 children. Those who violate the edict face a possible penalty of six-months in prison and/or a \$500 fine. County officials say that they are not planning to actually arrest anyone – for now. -GEG

One county in New York is taking extremely drastic measures in an attempt to force all children to get vaccinated for measles. Starting on Wednesday, any child that has not received the measles vaccine will be banned from all public places. That means that they will not be able to go to school, to church or to any store. In fact, just walking down the sidewalk will be a violation of this countywide “state of emergency”. Rockland County has essentially declared a state of medical martial law, and it is scheduled to last [for the next 30 days...](#)

Rockland County declared a countywide State of Emergency relating to the ongoing measles outbreak – the longest outbreak since the disease was eradicated in the United States in 2000, according to officials.

Effective at the stroke of midnight, Wednesday, anyone who is under 18 years of age and unvaccinated against the measles will be barred from public places until this declaration expires in 30 days

or until they receive the MMR vaccination.

So what has caused Rockland County to go to such extremes?

According to Rockland County Executive Ed Day, something had to be done because there have been 153 confirmed cases of measles in the county.

And the penalties that will be imposed upon anyone convicted of violating this state of medical martial law [are quite draconian](#)...

Anyone found in violation of the declaration could spend six months in jail and/or a \$500 fine, Day said. However, Day said the county is not looking to arrest people, but rather a means to grab the public's attention.

According to Day, county officials have been met with "pockets of resistance" from people unwilling to comply with health department advise and this played a part in the declaration.

Of course other communities all across America will be watching to see how the people of Rockland County respond to this declaration of medical martial law. If there is no uproar, it will set a

Last week, President Trump tweeted that it was time for the US to "fully recognize Israel's Sovereignty over the Golan Heights, which is of critical strategic and security importance to the State of Israel and regional stability."

Israel seized the Golan Heights region from Syria during the Six-Day War of 1967, in spite of calls by the international community to withdraw, and UN resolution recognizing Syria's sovereignty over the area. Israel expelled 130,000 Syrians from the Golan Heights in 1967.

The Golan provides over a third of Israel's fresh water.

Afek Oil and Gas, a division of Genie Oil, has obtained oil rights for the oil fields in the Golan Heights. Genie Oil board members include banking family scion Nathaniel Rothschild, former Vice President Dick Cheney, former Congresswoman Mary Landrieu, former CIA chief James Woolsey, former Treasury Secretary and financial advisor to Obama, Larry Summers, billionaire hedge-fund manager Michael Steinhardt, and co-chairman of Fox Corporation Keith Rupert Murdoch. Mr Trump's adviser and son-in-law, Jared Kushner, has family investments in Genie.

According to *Redress Online*, Genie's Israeli subsidiary cannot sell any oil it extracts from the Golan on the international oil market because that would violate UN resolutions.

However, if Washington declares the Golan to be part of Israel, then oil could be legally traded with the US and those with a financial stake in Golan oil will greatly prosper.

President Trump Signs Broad Executive Order to Promote Free Speech on College Campuses

su_note note_color="#ef1a7" text_color="#00000" radius="5"]Trump signed an executive order advising colleges to respect students' First Amendment right to free expression under the threat of losing \$35 billion in federal funding. The order was issued in response to colleges and universities that have banned presentations by conservative speakers using the excuse of protecting student safety. In addition, some campuses have imposed speech codes and free speech 'zones'. It is unclear how the new grant restrictions will be enforced, prompting concern from critics that research grants could be

stripped from schools that oppose the views and goals of the federal government and the grant-giving agencies, and that research will be micromanaged. [/su_note]

President delivers on promise to punish colleges that don't show they guarantee free speech on campus, and includes language on outcomes data and risk sharing. But it's unclear what force it will carry.

President Trump on Thursday delivered on his promise of an executive order that would hold colleges that receive federal research funding accountable for protecting free speech.

However, his bombastic rhetoric in a White House East Room ceremony wasn't matched by the modest language of the order.

"If a college or university does not allow you to speak, we will not give them money. It's that simple," he said Thursday.

But the [executive order](#) essentially directs federal agencies to ensure colleges are following requirements already in place. And it doesn't spell out how enforcement of the order would work.

It directs 12 federal grant-making agencies to coordinate with the Office of Management and Budget to certify that colleges

receiving federal research funds comply with existing federal law and regulations involving free academic inquiry. While the administration expects public institutions to uphold the First Amendment, the order says, private colleges are expected to comply with their “stated institutional policies” on freedom of speech. The free-speech directive doesn’t apply to federal student aid programs.

The document also directs the Education Department to publish program-level data in the College Scorecard on measures of student outcomes, including earnings, student debt, default rates and loan repayment rates.

And it requires the department to submit policy recommendations to the White House by January 2020 on risk-sharing proposals for colleges that participate in the federal student loan program.

The executive order puts extra force behind several policies the White House [has backed](#) previously. For example, earlier this week the administration released a report on priorities for reauthorization of the Higher Education Act that included program-level data and a new accountability system for

colleges.

President Trump has weighed in repeatedly on alleged suppression of free speech on campuses, especially speech by conservative students.

Most recently, he [announced plans](#) for an executive order addressing the issue at the Conservative Political Action Conference, an annual gathering of activists and elected officials.

“Free inquiry is an essential feature of this nation’s democracy, and it promotes learning, scientific discovery and economic prosperity,” the order reads. “We must encourage institutions to appropriately account for this bedrock principle in their administration of student life and to avoid creating environments that stifle competing perspectives, thereby potentially impeding beneficial research and undermining learning.”

The executive order [had been in the works](#) long before the president’s comments at the conservative event.

But it’s not clear what kind of teeth the order has beyond new certification requirements for institutions. A senior administration official told reporters on Thursday that federal agencies will

enforce
it the same way they enforce existing federal grant
conditions, which
colleges already are required to follow. The official didn't
address
details about how the order would be implemented.

Agencies covered by the order include the Departments of
Education,
Defense, Interior, Agriculture, Commerce, Labor, Health and
Human
Services, Transportation, and Energy, as well as the
Environmental
Protection Agency, National Science Foundation and NASA.

Telstra, Australia's largest telecom company, announced their

of these sites, but these are extreme circumstances and we feel this is

the right thing to do.”
