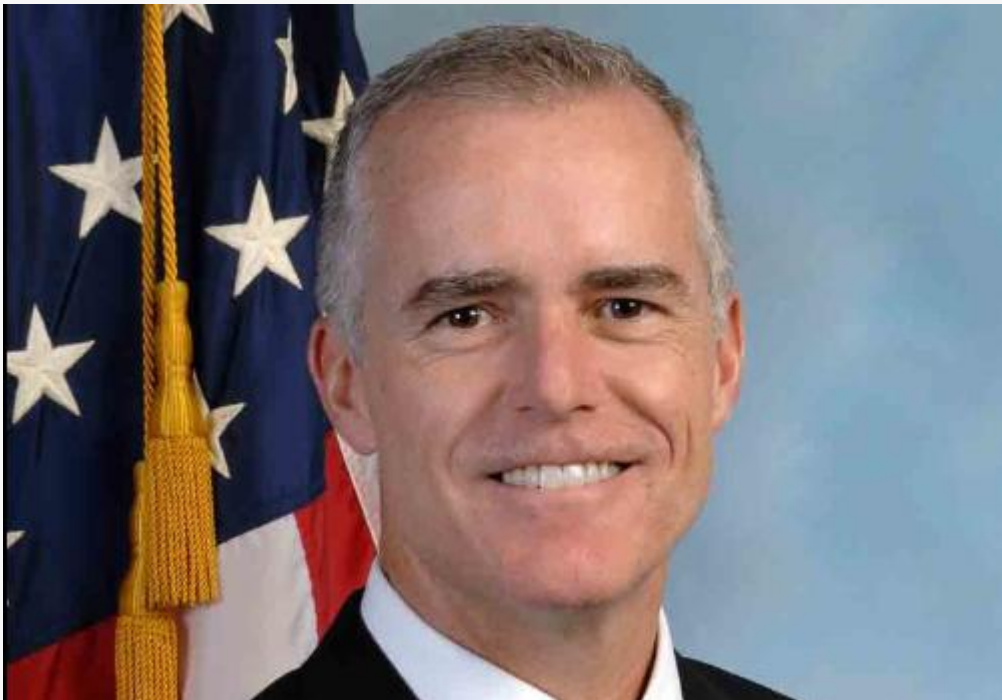

FBI Deputy Director Andrew McCabe Fired by AG Jeff Sessions

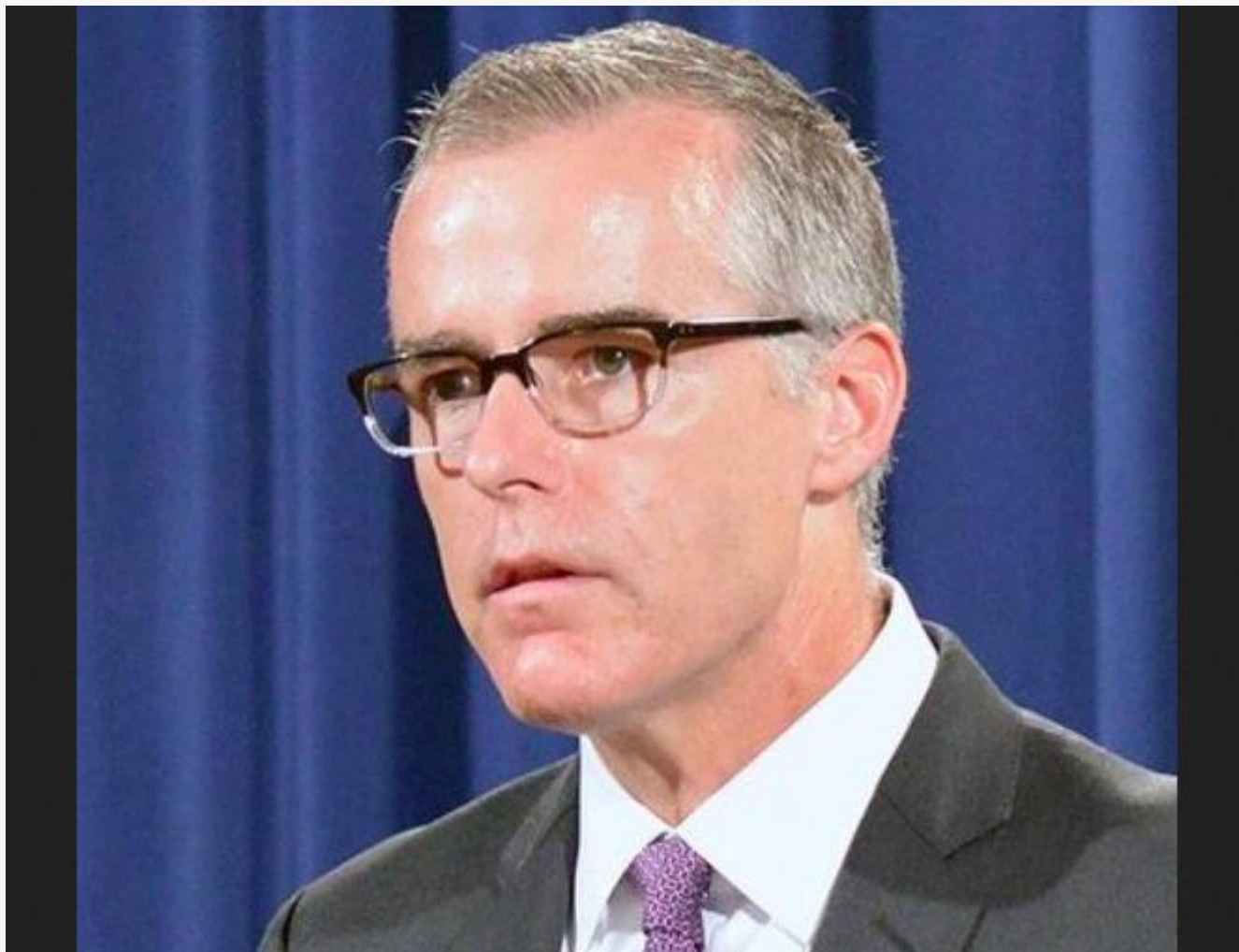
