



# Leaked Insider Recording From ABC News Reveals Network Executives Killed Bombshell Story Implicating Jeffrey Epstein

Amy Robach, ABC's Good Morning America Breaking News Anchor and 20/20 Co-Ancor, was recorded on a 'hot mic' during a conversation with a producer last August saying that she had convinced Virginia Roberts Giuffre, a victim of pedophile Jeffrey Epstein, to come forward with her story three years ago. # Cloudflare Drops 8chan for Posting Alleged El Paso Shooter Manifesto. FBI Caught Covertly Posting on 8chan in June.

On Saturday, a manifesto attributed to Patrick Crusius, the alleged El Paso shooter, was posted on 8chan, an image board where anyone can post images or content, and is known to be politically incorrect, with no monitoring from site administration. Cloudflare, a system that protects websites from cyber attacks, dropped 8chan and blamed the website for “inspiring” mass murder.

Apparently, the FBI is also posting on 8chan, which was discovered earlier this summer after an application for a search warrant for 8chan was unsealed, revealing that a federal agent , FBI Special Agent Michael J. Rod, was trolling the site, and trying to redirect blame for the April 27th synagogue shooting toward the Russian government, and away from the users’ conspiracy theories against the CIA or Mossad. ## **FBI agent accidentally reveals own 8chan posts; attempts to redirect white supremacist rage against Russia**

The [unsealing of an application for a search warrant](#) by the federal government on 8chan’s servers has unintentionally revealed that a federal agent has been trolling the site and attempting to redirect the users’ conspiracy theories against the Russian government instead of the CIA or Mossad.

The legal case stems from the [April 27th shooting at a California synagogue](#) by white supremacist and 8chan user John Earnest. The day of the shooting, Earnest is believed to have posted to 8chan a link to an anti-Semitic Pastebin manifesto and a not-so-cryptic suggestion that he was about to commit a murderous act of violence to back up his beliefs. In the accompanying affidavit to the search warrant application, FBI

Special Agent Michael J. Rod requests the “IP address and metadata information about Earnest’s original posting and the postings of all of the individuals who responded to the subject posting and/or commented about it. Additionally, agents seek information about any other posting coming from the IP address used by Earnest to post the subject posting.”

## **Canadian Chiropractor Fined \$100,000 for Criticizing Vaccines on Social Media**

A Canadian medical committee has ordered a chiropractor, Dr. Dena Churchill, to pay \$100,000 to the Nova Scotia College of Chiropractors for 'professional misconduct' after she posted messages on social media that vaccines could be harmful – and refused to delete her posts when told to do so. The committee claims that vaccines are outside of the chiropractor's scope

of practice. Canada's national chiropractic association's guidelines require chiropractors "not to discuss vaccines in any capacity." According to reports, Dr. Churchill surrendered her medical license and entered into a settlement agreement with the Nova Scotia College of Chiropractors which required her to admit to being "professionally incompetent as a result of incompetence arising out of mental incapacity." It is unknown whether Dr. Churchill made the admission of incompetency under duress, but she now is broke. [Question: Can you think of any instances in history where truth required the force of law and the threat of punishment to protect it? Neither can I. Only falsehood needs such protection.] GEG

A former Halifax-based chiropractor has been ordered to pay her regulator \$100,000 as part of a settlement agreement on charges of professional misconduct related to her sharing anti-vaccination views online.

[In a decision released publicly Thursday,](#)

a hearing committee of the Nova Scotia College of Chiropractors took into consideration Dena Churchill's "dire financial circumstances" and gave her 10 years to pay the money. But it also said if she has not paid at least \$30,000 by Jan. 2, 2022, the full amount becomes due immediately.

"Dr. Churchill's conduct brought the profession of chiropractic into disrepute," the hearing committee writes in its decision.

“Dr. Churchill has shown no remorse. There is genuine concern that she is ungovernable.”

The college [launched an investigation a year ago](#) after its registrar filed a complaint regarding Churchill’s extensive posts on social media about topics outside her scope of practice, most notably posts about vaccines that made disproved claims.

The guideline from the national chiropractic association, which is observed by the Nova Scotia college, is for chiropractors not to discuss vaccines in any capacity.

## **Licence surrendered in January**

In January, [Churchill surrendered her licence](#) and entered into a settlement agreement with the college, admitting she was “professionally incompetent as a result of incompetence arising out of mental incapacity.”

Churchill had been scheduled for a hearing in late May on 15 allegations of professional misconduct and one count of conduct unbecoming a chiropractor.

However, the hearing was cancelled earlier that month when Churchill entered into a settlement agreement with the college, admitting to the charges.

In that decision, [which was also released publicly Thursday](#), it is noted Churchill did not comply with multiple requests from her registrar to remove offending posts from a variety of social media accounts.

## **‘This is an egregious matter’**

A separate hearing was required after the two sides could not agree on costs, with the college originally seeking the full amount related to the investigation and administrative process to that point, which was \$178,831.34. The college later reduced its claim to \$100,000.

The committee disagreed with Churchill’s assessment that the finding of professional misconduct was “not an egregious breach” and awarded the college the full amount it was seeking.

“This is an egregious matter. Dr.

Churchill admitted she is guilty of professional misconduct. Dr. Churchill was responsible for social media posts outside her scope of practice which were harmful to the public.”

Koch organizations train political organizers and candidates. Many Republican lawmakers owe their careers to the Kochs. For people whose main business is making fertilizer and paper towels, the Kochs have been remarkably effective in politics. Not surprisingly,*

*the left hates them for it. Both the Koch brothers and their families, who by the way are very nice people, have been repeatedly and grotesquely maligned by the media. This, in turn, has convinced many conservatives that the Kochs must be on their side. Anyone who's been slandered by the New York Times has got to be doing something right. That's the idea. It's not a bad standard.*

*But in the case of the Kochs, conservatives might want to pause and rethink the relationship. As it turns out, the Kochs don't have much in common with conservatives. An economic policy that seeks to strengthen families? The Kochs denounce that as "crony capitalism," or "picking winners and losers." They think it's immoral. Controlling our borders? The Kochs consider that racist. A few years ago, Bernie Sanders noted that the Koch brothers are far to the left of him on immigration. Open borders? Quote: "That's a Koch brothers proposal," he said.*

## **Senator Josh Hawley Proposes Legislation to Bring Transparency and Accountability to Big Tech for Political Censorship**

Freshman Senator Josh Hawley (R-MO) authored a bill to end immunity granted to tech companies under Section 230 of the Communications Decency Act that shields them from publisher

liability lawsuits if the companies provide an open public forum. However, the tech giants have engaged in political censorship. Under the legislation, the big tech companies could earn their immunity if external audits prove that their algorithms and content-removal policies remain politically neutral.

**Sen. Josh Hawley (R-MO) proposed legislation Wednesday to end big tech companies' legislative immunity, which would prevent them from censoring conservative and alternative viewpoints without significant recourse.**

Sen. Hawley [proposed](#) the Ending Support for Internet Censorship Act, which updates the way the federal government treats social media companies under Section 230 of the Communications Decency Act (CDA).

The Missouri conservatives' legislation removes the big tech's immunity received under Section 230 unless they submit to an external audit that would prove that their algorithms and content-removal policies remain politically neutral. Sen. Hawley's legislation would only apply to large tech companies such as Google, Facebook, and Twitter, not small and medium-sized tech companies.

“With Section 230, tech companies get a sweetheart deal that no other industry enjoys: complete exemption from traditional publisher liability in exchange for providing a forum free of political censorship,” said Sen. Hawley in a statement Wednesday. “Unfortunately, and unsurprisingly, big tech has failed to hold up its end of the bargain.”

Hawley’s legislation [arises](#) as the Donald Trump Department of Justice (DOJ) and the Federal Trade Commission (FTC) will reportedly begin antitrust investigations into America’s largest technology companies.

Other conservatives, such as Rep. Matt [Gaetz](#) (R-FL) and Sen. Ted Cruz (R-TX), have [proposed](#) eliminating or amending Section 230 to curb big tech companies’ ability to censor conservative and alternative viewpoints.


Sen. Hawley’s legislation would:

- Remove automatic immunity under Section 230 from big tech companies.
- Give big tech companies the ability to earn their immunity through external audits.
  - However, the Federal Trade Commission could not certify large social media companies from immunity except for a supermajority vote by the agency.

- Big tech companies would have to pay for the cost of conducting the audits.
- The companies would have to reapply for immunity every two years.
- Preserves immunity for small and medium-sized companies.
  - The bill would not apply to companies with less than 30 million active monthly users, more than 300 million active monthly users worldwide, or those companies that have more than \$500 million in global annual revenue.

# **The 10 principles of the Charter**

## **1. Universal Access:**

All Canadians will have equal opportunity to participate in the digital world and the necessary tools to do so, including access, connectivity, literacy and skills.

## **2. Safety and Security:**

Canadians will be able to rely on the integrity, authenticity and security of the services they use and should feel safe online.

## **3. Control and Consent:**

Canadians will have control over what data they are sharing, who is using their personal data and for what purposes, and know that their privacy is protected.

## **4. Transparency, Portability and Interoperability:**

Canadians will have clear and manageable access to their personal data and should be free to share or transfer it without undue burden.

## **5. Open and Modern Digital Government:**

Canadians will be able to access modern digital services from the Government of Canada, which are secure and simple to use.

## **6. A Level Playing Field:**

The Government of Canada will ensure fair competition in the online marketplace to facilitate the growth of Canadian businesses and affirm Canada's leadership on digital and data innovation, while protecting Canadian consumers from market abuses.

## **7. Data and Digital for Good:**

The Government of Canada will ensure the ethical use of data to create value, promote openness and improve the lives of people—at home and around the world.

## **8. Strong Democracy:**

The Government of Canada will defend freedom of expression and protect against online threats and disinformation designed to undermine the integrity of elections and democratic institutions.

## **9. Free from Hate and Violent Extremism:**

Canadians can expect that digital platforms will not foster or disseminate hate, violent extremism or criminal content.

## **10. Strong Enforcement and Real Accountability:**

There will be clear, meaningful penalties for violations of the laws and regulations that support these principles.

# **Facebook and Instagram Blacklist Prominent Conservatives Including Infowars' Paul Joseph Watson**

Instagram and its parent company, Facebook, banned a number of conservative personalities from its platforms, including Infowars host Alex Jones, Infowars contributor and YouTube star Paul Joseph Watson, journalist and activist Laura Loomer, and Milo Yiannopoulos. Louis Farrakhan was also banned at the same time. Facebook and Instagram promised to remove any Infowars videos, radio segments, and articles posted by another account or page. Any Groups related to the banned figures or Facebook Events promoting them will also be removed. Critics say that this sets a chilling precedent for free speech, it is a formula for censoring not just websites and personalities, but their supporters, and that Facebook is openly punishing and rewarding users for their political opinions.

# Anti-Vaxxers Banned from Raising Money on GoFundMe

Anti-vaxxers have been banned from raising money on GoFundMe in an attempt to stop their message warning that vaccines can be dangerous. YouTube has demonetized anti-vaxxer videos, Pinterest has blocked search results for the term and Facebook claims to have reduced the prominence of posts spreading misleading information.

[Anti-vaxxers](#) have been banned from raising money on [GoFundMe](#) in an attempt to stop the spread of [conspiracy theories](#) and misinformation.

The crowdfunding platform announced it was carrying out a “thorough review” following reports that one campaigner had gathered nearly \$80,000 (£60,000) in donations.

Larry Cook, who promoted his fundraising efforts using [Facebook](#) adverts, targeted mothers with claims the medical community was covering up baby “slaughter”.

GoFundMe spokesman Bobby Whithorne said: “Campaigns raising money to promote misinformation about vaccines violate GoFundMe’s terms of service and will be removed from the platform.

“We are conducting a thorough review and will remove any campaigns currently on the platform.”

**Mark Zuckerberg, CEO of Facebook, Calls for Governments to Censor the Internet for ‘Harmful’ Speech on Issues Like Mass Immigration**

Mark Zuckerberg of Facebook called for governments to regulate speech, which does not target illegal content, but targets “harmful” content that is constitutionally protected. He said that speech on “divisive political issues,” such as mass immigration should be shut down by the government. FCC Commissioner Brendan Carr says that Facebook, which is worth \$500 billion, is motivated to keep its stronghold in the market and the new regulations would make it difficult for start-up companies to compete.
