



# **Jeffrey Epstein's Lawyers Requested that He Be Removed from Suicide Watch**

On July 25th, Jeffrey Epstein was either attacked or harmed himself in his jail cell when he was put on suicide watch. Last weekend, he reportedly hung himself in his cell after having been removed from suicide watch at the request of his lawyers. There is no camera footage, and the mandatory checks by guards were skipped, as they were reported to have been sleeping, and then fudged the paperwork. His cellmate was removed the day before the death. The medical examiner has yet to determine the cause of death. Epstein's lawyers, Jeffrey Schantz and Darren Indyke, recently hired defense attorneys to represent them. -GEG

**Jeffrey Epstein was taken off suicide watch last month per his lawyers' request, according to recent reports.**

Prison officials reportedly found Epstein's body in his Manhattan jail cell early Saturday morning. While his death is believed to be a suicide, an official report has yet to be released.

His untimely death while in federal custody sparked a series of questions, as he was believed to be on suicide watch after prison officials last month found the accused sex

trafficker semi-conscious in his jail cell with marks around his neck.

However, the billionaire was not on suicide watch at the time of his death. He was taken off in late July per his lawyers' request.

The *New York Post* reported:

*Epstein had been meeting with his attorneys for up to 12 hours a day before they requested that he be taken off suicide watch, sources familiar with the matter told the Wall Street Journal.*

*He had been downgraded to “special observation status,” which required two guards to make separate checks on him every 30 minutes, but that procedure was not followed, a source has told Reuters.*

According to Reuters, two jail guards are “required to make separate checks on all prisoners every 30 minutes,” but those mandatory checks were skipped the night of his death.

The AP added that guards on Epstein's unit, specifically, were working “extreme overtime shifts” to compensate for staffing shortages:

*The person familiar with the Metropolitan Correctional Center's operations told The Associated Press on Sunday that one guard in Epstein's unit was working a fifth straight day of overtime and another guard was working mandatory overtime. The person spoke on condition of anonymity because he lacked authorization to discuss jail operations publicly.*

The skipped mandatory checks are not the only point of interest. On Monday, the *Washington Post* reported that

Epstein's cellmate was removed the day before the alleged sex offender's death, even though a cellmate was required under the "special observation status." The cellmate should have been replaced with another, but that did not occur. The reason for the cellmate's removal is not yet known.

## **FBI Documents Claim Founder of Russia Today Accidentally Beat Himself to Death in Hotel Room**

The FBI just released the incredible results of its investigation into the death of the founder of *Russia Today*, a US-based media service that has a reputation of ignoring political corruption in Russia but accurately reporting political corruption in the US. The FBI says that Mikhail

Lesin killed himself by repeatedly smashing his head and upper body onto the floor while he was alone and intoxicated in his Washington DC hotel room. Lesin died in 2015, the FBI completed its investigation in October 2016, but the report was not released until last Saturday, which was fifteen months later. Most of the report was redacted so it is impossible to read the details of what the coroner wrote about the injuries.

*The FBI just released the results of their investigation claiming that the media mogul and founder of RT killed himself by repeatedly smashing his head and upper body into the ground.*

In November 2015, the Free Thought Project reported that Mikhail Lesin, the former head of media affairs for the Russian government, and the founder of Russia Today (RT), was found dead in the hotel room that he was staying at in Washington DC.

Originally, authorities announced that Lesin died from a heart attack.

However, the results of his autopsy released months later indicated a far more sinister cause of death and the heavily redacted FBI documents that were just released add to that story.

The documents, detailing the FBI investigation into Lesin's death were just released Saturday morning in spite of the investigation ending in October of 2016.

In spite of the original cause of death noted as a heart attack, a few months later, the District of Columbia's Office of the Chief Medical Examiner (OCME) and Metropolitan Police Department said that "blunt force injuries of the neck, torso, upper extremities and lower extremities" contributed to Lesin's death. *"The Office of the Chief Medical Examiner (OCME) has released the cause and manner of death for Mikhail Lesin... Cause of Death: blunt force injuries of the head,"* the

statement said.

Now, FBI investigators have released the results of their investigation claiming that the blunt force trauma all over his body was self-inflicted.

*“Mr. Lesin died as a result of blunt force injuries to his head, with contributing causes being blunt force injuries of the neck, torso, upper extremities, and lower extremities, which were induced by falls, with acute ethanol intoxication,” the report states.*

In other words, the FBI is claiming that Lesin got so drunk that he repeatedly and violently fell on things until he killed himself.

## **Obama Pentagon's Coverup of 'Bacha Bazi' Child Rape by Afghan Soldiers**

Under Obama, the Pentagon attempted to block an independent report on child sex abuse and rape of young boys among Afghan soldiers and police. Despite 93 congressmen requesting this document in 2015, it is still classified by the Pentagon. A high-level Afghan police official said that the practice of "bacha bazi", which is dressing young boys like women and making them dance and perform sex acts, no longer exists. However, the practice is actually growing, and local officials do nothing about it. Two years ago, while Obama was President, reports surfaced about US Marines being ordered to ignore child abuse by Afghan police officers, but the reports were marked classified by the Pentagon to prevent public knowledge of them. -GEG

Washington Post reports:

*The Pentagon tried to block an independent assessment of child sex abuse crimes committed by Afghan soldiers and police, instead insisting on the creation of its own report offering a far less authoritative review of human rights violations perpetrated by U.S. allies, according to an aide to Sen. Patrick Leahy (D-Vt.). [...]*

*But the results of SIGAR's unreleased inquiry, which was requested by 93 members of Congress in 2015, remains classified at the Pentagon's direction, raising questions about the military's transparency and the extent to which it is complying with laws meant to curb such abuse.*

*The Pentagon responded with "resistance" when Congress tapped SIGAR to conduct the probe, said Tim Rieser, an aide to Leahy, vice chairman of the Senate Appropriations Committee whose namesake legislation, known as the Leahy Law, requires the U.S. military to halt assistance to foreign military units found to have committed gross human rights violations.*

*Instead, senior Pentagon officials argued that SIGAR, which since 2009 has produced dozens of reports exposing corruption within the Afghan government and incompetence among Afghan security forces, lacked the jurisdiction for this particular task, Rieser said.*

“Afghan security personnel have been known to recruit young boys as servants, sometimes to use for sex. There is a broader practice in Afghan society to dress some boys as women and have them dance at gatherings. Known as bacha bazi, it was banned under the Taliban but revived after the U.S. invasion in 2001,” reports Alex Horton.

The Pentagon reportedly reviewed 16 allegations between 2010 to 2016. Horton says this number is unlikely to be accurate because of irregularities in reporting procedures and “an overall lack of unified guidance on reporting and record keeping relating to child sexual abuse.”

Two years ago, reports surfaced about U.S. Marines being ordered to ignore child abuse by Afghan police officers.
